Insert new condition A15

A15 Capacity of Child Care Centre

This approval does not approve the capacity of the child care centre (number of children accommodated in the facility), which is to be the subject of a separate future development application for the fit-out and operation of the child care centre. This separate future development application must also address any requirements of the Deed of Agreement between the proponent and council.

Insert new condition A16

A16 Turning Arrangements on Road 3

Prior to the commencement of stage 4 of the development, the proponent shall prepare a plan outlining the vehicle turning arrangements in stage 4 of the development to allow general traffic to turn around after entering Road 3 from Morrison Road before meeting the boom gate on Road 3. The plan shall be submitted for the approval of the Director-General prior to the commencement of stage 4 of the development.
