Description of proposal

Construction and operation of an approximately 51 kilometre gas pipeline to transport coal seam gas obtained from neighbouring Hunter Valley coal mines to the Liddell Power Station for use as a supplementary fuel for electricity generation at the Power Station. The coal seam gas would be fed directly into the Power Station's coal-fired boilers and is expected to displace up to 5% of the coal (by mass) required to generate a given amount of electricity.

Application of Part 3A

On 1 April 2008, the Director-General as delegate for the Minister for Planning formed the opinion that the project is a development of a kind described in Schedule 1 of *State Environmental Planning Policy (Major Projects) 2005* and is therefore a project to which Part 3A of the *Environmental Planning and Assessment Act 1979* applies. Consequently, the Minister for Planning is the approval authority for the project.
