COFFS HARBOUR CITY COUNCIL TECHNICAL SERVICES

Technical Services has requests for the resolution of WSUD details and sewer reticulation.

WSUD Details

The project details contain proposals for the use of central swale drains in the main road as part of the WSUD treatment of stormwater.

Council has recently amended their WSUD policy such that central swale drains are excluded from the policy.

Due to the time constraints involved in a redesign of this issue Council has agreed that the Development Consent can be conditioned such that the WSUD design is modified by removal of the swale drains prior to submission of a Construction Certificate (C.C.) application.

<u>Sewer</u>

The original project details showed a small section of the development at the Southwest corner that required a small pump station to enable sewer.

Council has recently changed its sewer design policy to enable the use of a "low pressure" system.

The project drawings have been amended to show a low pressure system.

COFFS HARBOUR CITY COUNCIL NEIGHBOURHOOD PARK

CHCC had requested that provision be made for a neighbourhood park to incorporate a "kick around" area.

During discussions with Council there was also concern raised about the location of topsoil containing potential artefacts being placed in the area of the park, as it would restrict Council's ability at a later date to undertake works if required.

It has been possible to incorporate a neighbourhood park area in the proposed public reserve located in the Northwest of the site and West of the entry road.

A new project plan numbered 120 has been prepared to detail a potential park.

A new project plan numbered 121 has been prepared to detail the archaeological topsoil placement.

Council Development Control Plan (DCP) and Developer Contribution Plan indicate an area to be acquired for neighbourhood park use. The area indicated for park was inappropriate considering the constraints, however in keeping with the DCP the area for acquisition has been detailed in the same area.
