### SCHEDULE 2

1. In the list of definitions, delete the term "MSB" and its definition, and insert the following terms and definitions in alphabetical order:

EA Mod 6	<i>Integra Coal Project, Section 75W Modification Application</i> , prepared by Glencore, dated 11 November 2016
SANSW	Subsidence Advisory NSW
2. Delete all references to "MSB" and replace with "SANSW".
3. In condition 2 of Schedule 2:
  - (a) delete the word "and" in sub-paragraph (f); and
  - (b) delete sub-paragraph (g) and insert the following:
    - (g) EA Mod 6; and
    - (h) project layout plan.
4. In condition 12 of Schedule 3:
  - (a) after the words "the project does not", insert "exceed"; and
  - (b) after the words "contribute to", insert "an".
5. In condition 6 of Schedule 5, delete all words after sub-paragraph (c) and insert the following:
  - (d) approval of a modification to this consent, the Proponent must review and if necessary revise, the strategies, plans and programs required under this consent, to the satisfaction of the Secretary.


Within 4 weeks of conducting any such review, the Proponent must advise the Secretary of the outcomes of the review, and provide any documents that have been revised to the Secretary for review and approval.

*Note: This is to ensure the strategies, plans and programs are updated on a regular basis, and to incorporate any recommended measures to improve the environmental performance of the development.*
6. In condition 12 of Schedule 5, after the word "commission", insert ", commence".
7. In condition 13 of Schedule 5:
  - (a) delete the words "commissioning the" and replace with "commencing each"; and

(b) after the words “in the audit report”, insert “, and a timetable for the implementation of any measures proposed to address the recommendations”.

8. Delete Appendix 3 and replace with the following:


