I refer to your letter of 13 August 2010 concerning MP 08_0104 MOD 2 modification application for the Redevelopment of the College of Fine Arts Project at UNSW Paddington Campus and your request to have the Major Project modification application fee reduced and further information provided in a letter dated 26 October 2010.

The Department acknowledges the modifications proposed are minor and that the provision of the educational facilities is funded by Commonwealth Government grants and the project would provide a public benefit through expansion of the educational, research and cultural functions at the Campus, including providing a new public gallery.

The full assessment fee relating to this project is set at \$33,330.50 in accordance with the Environmental Planning and Assessment Regulation 2000 (EP&A Regulation). Whilst it is rare for the Department to reduce or waive a fee payable under the EP&A Regulation, it is considered that the educational facilities being delivered would provide significant social benefit and the assessment required for the modifications would not warrant the full fees. Therefore, the Department is willing to reduce the modification fee for the proposal to \$5,000. As you have already paid \$33,330.50, the Department will utilise the extra funds of \$28,330.50 to offset future modification applications as per Option 3 in your letter.
