Planning and Infrastructure has received an application from Joe White Maltings Pty Ltd to modify the project approval for the Minto Malting and Grain Project at Stonny Batter Road, Minto in the Campbelltown local government area.

The proposed modification involves the construction of twelve (12) new steel silos to increase malt and grain storage capacity at the site. There would be no change to the approved import, production or export limits of the facility. The modification application is to be assessed and determined under Section 75W of the *Environmental Planning and Assessment Act 1979*.
