#### **Dear Chloe**

Thanks for the opportunity to comment on this information.

On the basis of a review of the information provided , the Technical Memorandum does not appear to fully address the comments previous raised by the EPA in our letter to DPE dated 15 December 2016 (our reference DOC16/606238-08).

The EPA has previously recommended the following be undertaken to support this modification application:

- A noise impact assessment in accordance with the NSW Industrial Noise Policy.
- An assessment of road traffic noise impacts in accordance with the "NSW Road Noise Policy".

This would assist in determining compliance with the existing noise limits specified for the premises (including transport noise).

The noise assessment information provided to date does not appear to adequately assess noise impacts from the premises (both existing and associated with the proposed modification).

This includes utilisation of a noise impact assessment methodology and approach consistent with the EPA Industrial Noise Policy & NSW Road Noise Policy.

Noise impacts from the premises should include all activities at the premises, including transport.

The EPA would like to discuss these matters further with DPE as the above matters appear unresolved.

Council has reviewed the additional information submitted by Cardno on behalf of Joe White Malting, Minto.

Following that review, Council has two issues that require (in our opinion) some additional responses from the applicant. They are:

• The traffic volume comparison in table 1 of Cardno's 'Response to RFI' (Appendix 3) contains data for all traffic. Council was specifically interested in the increase in the number of heavy vehicles that would be utilising the roads. The percentages identified in the table are very minor, however, the question asked was in relation to the increase in heavy vehicle traffic, not overall traffic – as a measure of the potential impacts on the road surface over time.

The question raised in Council's letter of late September 2016 specifically mentioned equivalent standard axle loading, but this has not been considered in the table as the percentage increase of heavy vehicles has not been nominated. This is of most interest in determining the potential impacts increased b-double traffic (at 45tonnes payload) might have on roads over time.

• The truck routes on page 6 and in Appendix C of the proponent's 'Operational Traffic Management Plan' do not appear to consider the 40 tonne load limit that is applied to the bridge on Ben Lomond Road (between Airds Road and Carey Grove). Further, the right turn proposed from Campbelltown Road to the Hume Highway north is not possible. There are no right turn facilities in that location. A revised route for those movements impacted by the load limit and turn treatments shall be provided.

Apologies for the delay in responding. Council will undertake a fast review of any revised information that is received in response to the points above.
