## Re: Modification to residential subdivision at Belle O'Connor Street, South West Rocks

Thank you for your e-mail dated 31 March 2017 about the proposed modification to the project approval for the residential subdivision at Belle O'Connor Street South West Rocks seeking comments from the Office of Environment and Heritage (OEH). I appreciate the opportunity to provide input.

The OEH provided initial comments on the proposed modification previously in a letter dated 14 February 2017. The applicant's planning consultant, Keiley Hunter Town Planning, has since submitted to the Department of Planning and Environment (DPE) a response to the issues raised in our letter.

After reviewing the response letter from Ms Hunter and consulting with her by telephone, the OEH supports the proportion of proposed E2 offset land (i.e. 3.7ha) as described in that letter that will compensate for the biodiversity impacts of Stages 10 and 11.

However, the modification application does not mention the proposed proportional offset arrangements, and does not include any proposal to change the Planning Assessment Commission Project Approval Conditions B14 and E8 to enable staging of the offset requirements or an alternative process for developing and implementing the Vegetation Management Plan (VMP) for the offset area.

Consequently, the OEH recommends that:

1. Prior to determining the modification application, the Department of Planning and Environment should seek amendments to the proposal to include a description of how Conditions B14 and E8 will be amended to accommodate the proposal.

- 2. Any consent issued for the modification should include conditions that require:
  - a. The proportion of proposed E2 offset land (i.e. 3.7ha) to be dedicated to the council prior to the council releasing the Subdivision Certificate(s) for Stages 10 and/or 11; and
  - b. A comprehensive Vegetation Management Plan to be prepared for the proportion of proposed E2 offset land (i.e. 3.7ha) in consultation with the council and OEH, and approved by the council prior to issuing of the Construction Certificate(s) for Stages 10 and/or 11.
