Ivanhoe Coal is seeking to modify conditions 7 and 8 of Schedule 2 of the consent pursuant to Section 4.55(2) of the EP&A Act to allow for: <ul style="list-style-type: none"><li>• receival and unloading of one coal laden train (nominal net tonnage of up to 3,900 tonnes (t) per train) each day (Monday to Saturday between 7:00 am and 6:00 pm, and Sunday between 8:00 am and 6:00 pm); and</li><li>• transfer of coal received via rail to the overland conveyor for dispatch to WCS.</li></ul>

The proposed modification, to unload a single coal laden train per day would be within the objectives of the facility's approval, being the handling and transportation of coal with a reduced reliance on road transport for coal deliveries, and thus is substantially the same development as the original project.
