- Clements and Associates report dated 2 July 2010 and updated reports prepared by Tree and Landscape Consultants (TALC) dated 13 December 2010 and 8 July 2011.
- b) The trees identified on the endorsed plans as being retained shall be protected prior to and throughout the demolition / excavation / construction process in accordance with the arborist report submitted with the EA / PPR (including the preparation of a Bush Regeneration Restoration Plan) and the relevant conditions of this Approval.
- c) Sixteen (16) additional trees of 75 litre pot size are to be planted within a suitable area of the site. In this regard, a plan showing the proposed location of the trees is to be submitted to the Director General of the Department of Planning and Infrastructure (or delegate) for approval prior to the occupation of the first residential building within Stage 1. These trees are to consist of the following species:
 - Lophostemon confertus (Brush Box)
 - Eucalyptus saligna (Sydney Blue Gum)
 - Syncarpia glomulifera (Turpentine)
