## Notification of Penrith Nepean Hospital Redevelopment, Derby Street, Kingswood, Penrith NSW

We write on behalf of New South Wales Health Infrastructure to notify Penrith City Council of the proposed redevelopment of Penrith Nepean Hospital and to provide you with the opportunity to make comment.

An initial Project Application and Preliminary Environmental Assessment has been submitted to the Department of Planning, and it is anticipated that the proposed redevelopment of the Hospital, as outlined below, will be declared a "Major Project" under Part 3A of the Environmental Planning and Assessment Act 1979 by the Minister.

We are aware that discussions have already been held with Council on the proposal, however this consultation is requested to ensure that any comments are formally addressed in the Environmental Assessment which must be prepared as part of the application for approval of a Major Project.

## PROPOSED WORKS

The following provides a summary of works proposed, with relevant plans attached for your consideration. The proposed redevelopment works will include:

- \_Construction of a new East Block comprising of:
- \_Car parking at level one;
- \_An Ambulatory Procedure Centre (APC) at level two including six operating theatres, 20 extended day only beds, nine surgical day only beds, four medical day only beds, and eight surgical out-patients clinics including the pre-admissions clinic;
- \_60 overnight surgical beds at level three, 30 of which will be relocated from their current location in West Block and will concentrate surgical services within the new East Block; and
- \_Refurbishment and expansion of the Intensive Care Unit (ICU) in its existing location from 19 to 24 beds, including research space at level three;
- \_Expansion of the in-centre renal dialysis service from two stations to eight stations in the vacated surgical bed space in West Block;
- \_Connectivity between the new East Block and the main North South spine of the hospital with a pedestrian way between East Block and South Block main entrance;
- \_Major enhancements and upgrading of engineering services; and



\_Associated car parking.
