## Re: Installation of a Needle/Syringe automatic vending machine and 120litre sharp disposal bin at the Auburn Community Hub

Access to clean injecting equipment is the single most effective way of reducing the transmission of HIV and Hepatitis C.

As you may be aware, the Needle and Syringe Program (NSP) has operated in Auburn since the early 1990s, providing HIV and Hepatitis C prevention services to the people of the Auburn area. Current high rates of Hepatitis C infection mean that it is crucial to increase access to sterile injecting equipment, and Sydney West Area Health Service is planning to install a needle and syringe vending machine on the outside wall of the proposed Community Hub at Auburn Hospital.

This installation is an enhancement of the existing NSP outlet. The machine will provide additional access to clean injecting equipment on a 24-hour basis.

Sydney West Area Health Service currently has 8 Needle/ Syringe dispensing machines in service across the area. Machines have been operating in NSW since 1992 with approximately 102 machines installed on Health facilities across NSW.

A survey of Community Attitudes to the provision of NSP Services, which was undertaken in the Penrith / St Marys area in 2001 indicates that the community believe NSP Services should be provided from a Health run facility, with the majority of respondents citing hospital locations, (such as the currently proposed Auburn location) as the most appropriate.

The Auburn Hub will also provide 24-hour access to a sharps disposal bin, a prerequisite for the installation of a vending machine under *The Needle and Syringe Policy and Program Guidelines for NSW* (2006:6). Local disposal contractors indicate that approximately 75 per cent of the sharps waste is medical in nature; therefore the bin will provide a safe disposal location for the whole community, especially those such as diabetics, who generate substantial number of medical sharps.

Hospital security services have been briefed on the proposed vending machine installation, however, on the basis of the currently existing machines, it is not anticipated that there will

be any additional risk to the community.
