- "I&I NSW" in condition 5 of schedule 2, conditions 31, 40 and 41 of schedule 3 and commitment 6.4.1 of Appendix 3, and replace with "DRE";
- "DECCW" in conditions 9, 17, 20, 21 24, 25 and 31 of schedule 3 and commitments 6.5.4, 6.8.1 and 6.8.5 of Appendix 3, and replace with "EPA";
- "DECCW" in conditions 34, 36, 38 and 42 of schedule 3 and commitments 6.6.10, 6.7.1 and 6.10.1 of Appendix 3, and replace with "OEH";
- "DECCW" in condition 41 of schedule 3, and replace with "OEH, EPA"; and
- "Heritage Branch" in condition 42 of schedule 3 and commitment 6.11.2 of Appendix 3, and replace with "Heritage Council".
- 3. Delete all words after "statement of commitments;" in condition 2 of schedule 2, and insert:
 - MOD 1 EA; and
 - conditions of this approval. (d)

Notes:

- The general layout of the project is shown in Appendix 2.
- The statement of commitments is reproduced in Appendix 3 (excluding the commitments which are directly reflected in, or inconsistent with, the conditions of this approval).
- 4. Delete the ground vibration criteria for the Aboriginal axe grinding groove site in condition 10 of schedule 3, and replace with "C 175".
- 5. Insert the following after footnote 'b' in condition 10 of schedule 3:
 - ^C Subject to meeting incremental limits under condition 10A.
- 6. Insert the following condition after condition 10 of schedule 3:
 - 10A. The Proponent shall ensure that blasts on site do not cause any exceedance of the following incremental ground vibration limits at the Aboriginal axe grinding site (REA86):
 - (a) 60 mm/s;
 - (b) 120 mm/s; and
 - (c) 175 mm/s;

without the prior approval of the Director-General.

In seeking the Director-General's approval for an incremental increase in the ground vibration limit from (a) to (b) to (c) above, the Proponent shall provide a report prepared by a suitably qualified expert, in consultation with OEH and relevant Aboriginal groups, demonstrating that blasting at these limits is not having any discernable impact on the Aboriginal axe grinding groove site (REA86).

7. Insert the following after condition 17 (f) of schedule 3:

Note: The Blast Management Plan should be prepared and implemented in accordance with the agreement between the Proponent and Coal & Allied as detailed in the MOD 1 EA.

- 8. Delete "1,762" and "3,720" where they occur in Table 16 in condition 32 of schedule 3, and replace with "1,767" and "3,725" respectively.
- 9. Insert the following after the third open bullet point in condition 42 (b) of schedule 3:
 - o managing the incremental ground vibration limits under condition 10A above;
- 10. Delete the words "Umwelt archaeologists" in commitment 6.10.1 of Appendix 3 and replace with "an appropriately qualified archaeologist".
- 11. Insert the following after the first figure in Appendix 2:
