The proposed changes are incorporated into the approval for stage 6 (MP 10_0031) in order to provide a mechanism for the Director-General of the Department of Planning and Infrastructure to vary the hours of construction under specified conditions.

SCHEDULE 2

- 1) In Part D, under the heading 'Construction Hours' insert new condition D2A as follows:
- D2A. The hours of construction may only be varied in order to undertake works with the prior written approval of the Director-General. Any request to alter these hours of construction shall be:
 - a) justified and considered on a case by case basis;
 - b) accompanied by details of the nature and need for activities to be undertaken during the varied construction hours;
 - c) accompanied by written confirmation from Rockdale City Council and RailCorp confirming that:
 - consultation to vary the hours of construction has been undertaken;
 - acknowledgement of the necessity of the works to be undertaken;
 - agreement of the dates and times of the extension to hours of construction; and
 - d) accompanied by any information necessary to evaluate the amenity or environmental impacts of the proposal.

Upon any approval of a variation the proponent must notify all occupants of residential building 'Vine', by letter, prior to the commencement of work. The notification letter is to provide details of the dates and times of the extended construction hours.

- 2) In Part D, insert new condition D2B as follows:
- D2B. The construction of Stage 6 is to be carried out having regard to the Environmental Management Plan entitled, "Environmental Management Plan for Construction of Discovery Point Stage 6 ARC" prepared by Ganellen and dated 1 February 2013. The Environmental Management Plan is to be updated regularly to ensure compliance with current statutory and regulatory environmental, health and safety requirements.
