Preliminary comments:

Council's LEP194 controls require the top storey to be 60% of the floor below. In this regard the top storey (and associated ancillary structures) is to be setback from the external edge of the building to recess the top storey and reduce the massing of the building at the uppermost level.

Pergola structures to the edge of the buildings is not supported as recessing of the top storey loses its design intent. It is recommended that pergola structures be setback, preferrably 1.5m-2m where possible.

Pergola structures must be of light weight material finish and open style to ensure the bulk, scale and design of the top storey remains relatively unchanged.

I hope this is of assistance.
