Tree Schedule Sheet

This Schedule of site trees has been prepared in conjunction with Mr David Ford, principal of Treescan P/L, consultant Arborists for the project. The location of trees was determined by survey for much of the site, but where survey information was deficient or found from site investigation to be in error, amendment or additions have been made to the plans and to the schedules. Due to the large scale of the site, and many areas not being the subject of current detailed design documentation, it is understood that there will be omissions and errors – however, overall we are confident that the documented trees provide a good representation of the trees on site. The estimates of height, width and trunk dimension are representative rather than completely accurate, just given the quantity of trees under consideration, and the assumption that detailed DA's for site areas will provide further opportunity to complete further detailed assessment of trees.

The accompanying sheets provide Staging Plans generally indicating trees to be retained / protected, or removed to allow for Stage 1A of the proposed site works, and then for works after Stage 1A. DA documents have been prepared for Stage 1A works, and we note the tree information, and also the information available to assess likely impacts, will in due course be improved with progression of design development documentation. These sheets also indicate the general proposals for new tree planting for these respective works, so that this can be seen alongside tree removal information to provide knowledge of extent of replacement planting.
