#### SCHEDULE 2 CONDITIONS

• Insert the following new condition D21 after condition D20:

#### D21 Use of the Temporary Car Park

- a) To minimise impacts associated with construction traffic and on-street parking, where possible and where capacity allows, all workers associated with hospital campus redevelopment works are to park their vehicles on-site within the dedicated temporary car park.
- b) All workers are to be made aware of the temporary car park through appropriate means of communication (i.e. site induction etc.) and their obligation to use the on-site parking available.
- c) The temporary car park is not to be made available for use by hospital patents, visitors or staff. In this regard, access to the car park is to be controlled by the use of a key card operated boom gate.
- Delete condition E7 and replace with the following:

#### E7 Cessation of Use of the Temporary Car Park

a) Upon the issue of an occupation certificate for final development works approved under project approval MP10\_0070, use of the temporary car park is to cease operations and is to be restored to its original state with three months following the issue of the subject occupation certificate.

Confirmation of the completion of these works is to be provided to the satisfaction of the Certifying Authority and forwarded to the Department of Planning and Infrastructure for their records.

- b) Notwithstanding a) above, the continued use of the temporary car park by construction workers associated with future redevelopment under the approved Wahroonga Estate Concept Plan is permitted subject to separate approval being obtained prior to the expiration of the three month period specified in a) above.
- Delete condition F5.
