In regards to Reference A, the proponent seeks approval for a minor modification to the Environmental Assessment such that all references to a WTG capacity of up to 3 MW is amended to read 3.5 MW. The proponent requests that this is recognized by amending Condition of Consent No. A1 (b) to read:

“Environmental Assessment Capital II Wind Farm Bungendore (Monteath and Powys Pty Ltd, December 2010), *as amended by letter dated 16<sup>th</sup> April 2013.*”

In accordance with Condition of Consent No.E3, the proponent must still submit a revised noise assessment once the turbine and final layout has been determined. No amendment to this condition is sought and the revised noise assessment must show compliance with the noise criteria detailed in Reference A.

The project remains consistent with all other criteria approved in Reference A, including the physical dimensions of each wind turbine generator.
