RE: ABORIGINAL HERITAGE IMPACTS, MODIFICATION 3, CAPITAL II WIND FARM, BUNGENDORE

BACKGROUND

The Capital II Wind Farm (CFII) was approved on 1 November 2011 (MP 10_0135). The approval included approval for an overhead transmission line for the project (approved OHL).

A modification to the approved OHL Capital II Wind Farm (Modification 3 – Transmission Line) is requested from the Department of Planning & Environment (DoP&E). The modification proposes a new section of overhead transmission line (proposed OHL). The proposed OHL and approved OHL run parallel to the existing OHL at Capital Wind Farm.

The DoP&E have requested *‘a revised Heritage Impact Assessment that demonstrates the proposed transmission line will not impact upon any items of Aboriginal heritage significance’*.

The proposed OHL alignment and the location of the approved transmission line has now been confirmed and an assessment of the Aboriginal heritage impact is provided in this report.

METHODOLOGY

In order to establish the impacts of the proposed modification, a new search of the NSW Office of Environment and Heritage (OEH) Aboriginal Heritage Information Management System (AHIMS) database was undertaken on 10 June 2014 covering an area of approximately 20km² surrounding the proposed area of works; this is the same search area as the search undertaken in 2010 for the Environmental Assessment.

The sites were then plotted and overlayed on the modified plans to determine if any known sites were intersected by the proposed OHL. Records from the 2010 AHIMS search and field survey findings were compared with the 2014 search results; the 2014 AHIMS search included all 2010 AHIMS search records and the new field survey findings (from the Austral Archaeology June 2010 field results).

THE MODIFIED PROPOSAL

A new additional section of OHL ('proposed OHL') is now proposed (refer **Appendix 2**) running adjacent to the western side of the existing OHL between E11 and WTG22 (in a north-south direction). This new section connects to the approved OHL, to the east of WTG 22.

FINDINGS

A total of 161 Aboriginal objects and places have been recorded within the search area (see **Appendix 1**); this includes the 74 found during the 2010 AHIMS search and the items recorded during field work in 2010, as well as some additional items not recorded in either search. These have been plotted and overlaid with the modified proposal (see **Appendix 2**).

None of the recorded sites intersect the proposed OHL (see **Appendix 2**).

Archaeological Survey of OHL alignments

The location of the proposed OHL (the modification) is included within the overall CFII study area by Austral Archaeology. The Austral Archaeology 2010 report *Capital Wind Farm II Tarago Region, NSW Aboriginal Archaeological & Cultural Heritage Assessment* included a prediction of likely site locations, site types and degree of site preservation of artefacts based upon the archaeological context, local Aboriginal history, and past land disturbances in the study area. The report reviewed past studies in the area and involved a search of the AHIMS database. In terms of artefact site locations, the following was predicted:

- Sites may be found on all landforms within the study area.
- Sites are most likely to occur on lower slopes and alluvial landforms.
- Sites may also occur on ridgeline crests.

Based on these predictions, three survey areas were identified for detailed survey on foot. During the construction of Capital 1 Wind Farm any additional artefact findings were reported and recorded for the project site in 2009. The route for the proposed OHL (the modification) runs parallel to the existing OHL for Capital 1 Wind Farm, so therefore captures an area where any additional artefact findings were recorded.

CONCLUSION

Construction or operation of the proposed modification would not impact upon any known items of Aboriginal significance; therefore no additional mitigation measures have been provided. It is recommended that the measures included in the Conditions of Approval for the Project be applied to the modified proposal including:-

B8. Disturbance to the Aboriginal objects CWF2-PAD01, CWF2-PAD02, CWF2-S-05, CWF2-S-06, CWF2-1F-07, CWF2-S-14 and CWF2-1F-20 must be avoided for the life of the project.

B9. Mitigation strategies must be considered and implemented for each of the 63 listed Indigenous sites that are subject to mitigated impacts, identified in Tables 8.1 and 8.2 of the *Final Aboriginal Archaeological & Culture Heritage Assessment Report*, contained in the document referred to under condition A1 (c). This information must be detailed in the CEMP and be prepared in consultation with OEH.

C14. As part of the CEMP required under condition C13, the Proponent shall prepare and Implement:

(e) an **Indigenous Heritage Management Plan**, to outline the measures to minimise and manage impacts to indigenous items and sites, as required under condition B9. The Plan shall be informed by recent archaeological surveys and test excavations conducted on the properties adjacent to the project site and developed in consultation with the relevant Aboriginal stakeholders and OEH.

D9. If during the course of construction, the Proponent becomes aware of a nonindigenous heritage item or any previously unidentified significant Aboriginal item(s), all work likely to affect the item(s) shall cease immediately and the Proponent must contact OEH to determine an appropriate course of action, prior to the recommencement of work in the vicinity of the item.

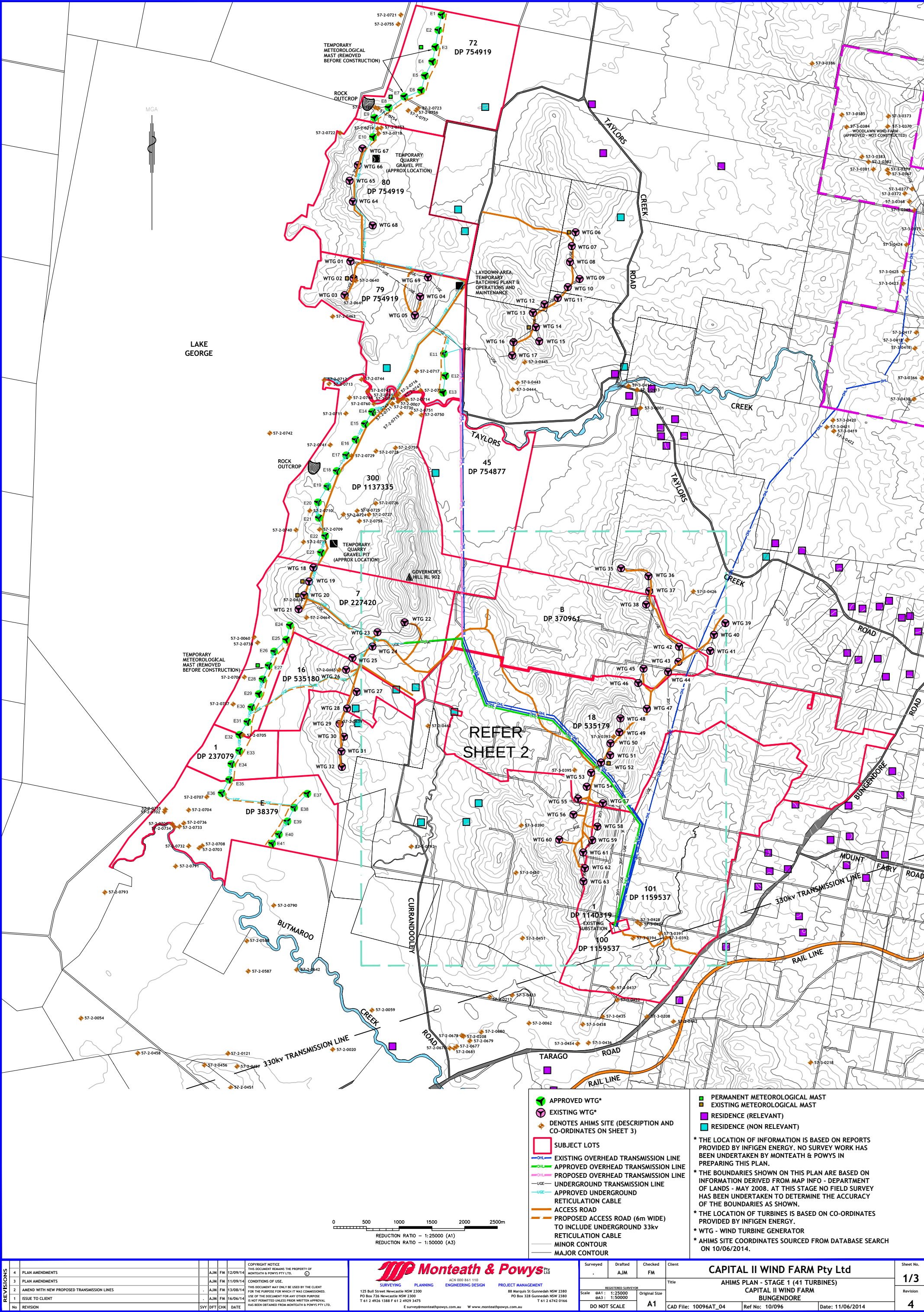

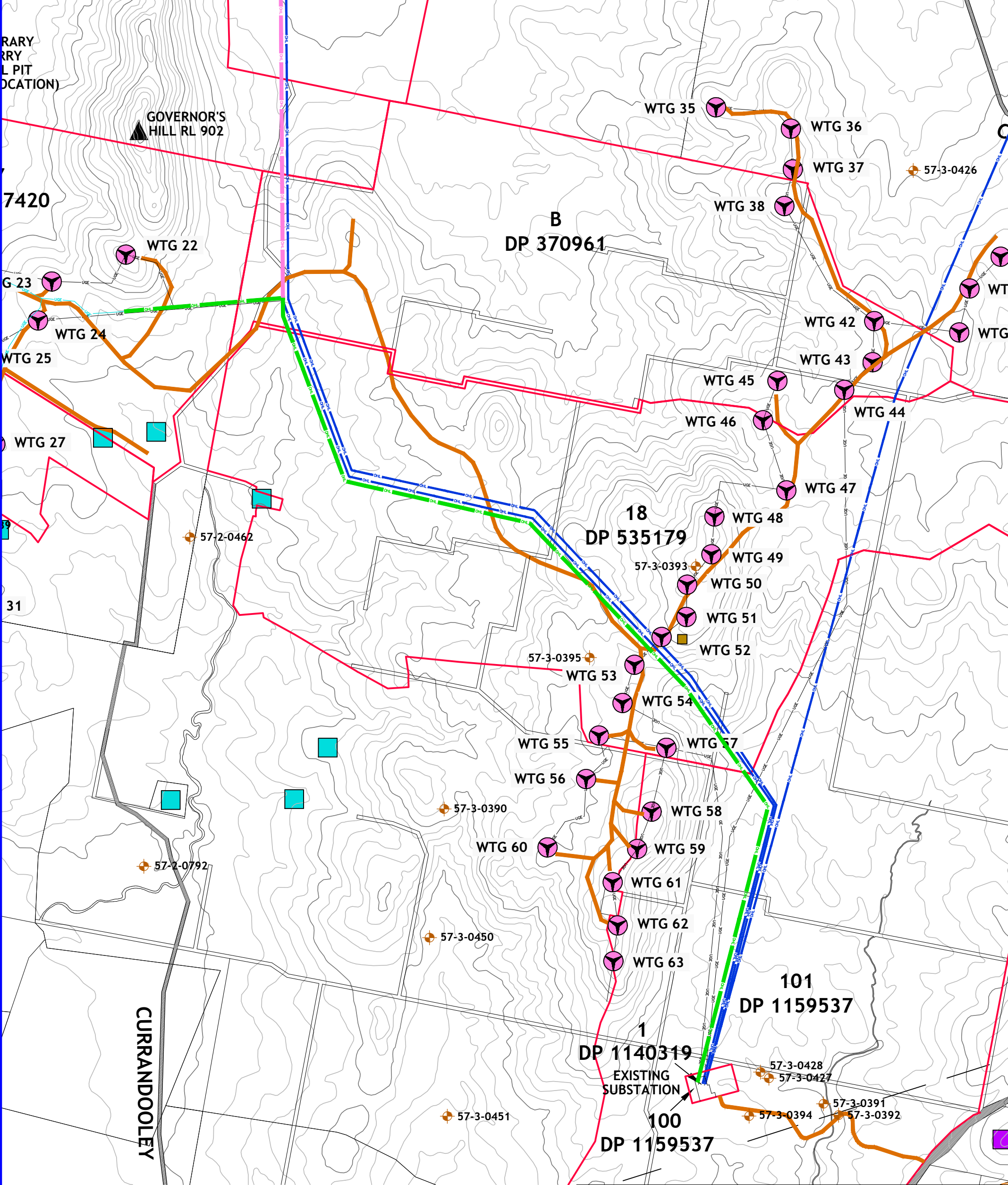
