The Maules Creek Coal Mine Olivedene Water Supply Modification (the Modification) includes the continued use of the water supply pipeline and associated infrastructure to convey groundwater to the MCCM from the Olivedene bores.

How is the modification substantially the same as the original development?


The MCCM has demonstrably remained an open cut coal mining operation with only minor changes (such as the realignment of the CHPP and associated facilities) approved under PA 10\_0138 (as modified).  
  
This would also clearly continue to be the case if the Modification was approved.
