Prior to the issue of a Strata Certificate, the Proponent shall submit to the Director-General and Certifying Authority, amended Strata Plans as follows:

- Sheet 4 of 23: The car park entry and exit on level 1 shall be changed to reflect the entry and exit illustrated on approved drawings A0011A dated 25 October 2012 and A8101 dated 5 April 2011.
- Sheets 4, 5, and 6 of 23: Seventeen (17) car spaces notated as CS16 to CS20, CS26 to CS28, CS41 to CS43, and CS57 to CS62, shall be notated as visitor parking common property.
