Transport for NSW (TfNSW) have reviewed the Modification Report prepared by Umwelt and dated November 2020.

It is noted that the original Section 138 of the *Roads Act (1993)* concurrence issued by Roads and Maritime (now TfNSW) dated 14 August 2019 has now lapsed (consent/concurrence is only valid for a period of 6 months).

Should the Department of Industry, Planning & Environment (DPIE) approve the proposed modification, TfNSW concurrence is required in accordance with Section 138 of the Roads Act (1993) as the roadworks required affect the New England Highway a classified State road. As such, the works are to be designed in accordance with the current version of Austroads Guide to Road Design (with Roads and Maritime Services supplements) and relevant Australian Standards to the satisfaction of both TfNSW and DPIE.

Furthermore, TfNSW highlights that in determining the application it is the consent authority's responsibility to consider the environmental impacts of any road works which are ancillary to the development, such as (inter alia) removal of trees, relocation of utilities, stormwater management, etc. This includes any works which form part of the proposal and/or any works which are deemed necessary to include as requirements in the conditions of development consent. Depending on the level of environmental assessment undertaken to date and the nature of the works, DPIE may require the developer to undertake further environmental assessment for any ancillary road works.
