Mannering Coal Mine Modification 5 – Response to submission

1. The Biodiversity and Conservation Division recommends that a consent condition is created that requires Delta Coal to prepare an Aboriginal Cultural Heritage Management Plan for the Delta Coal Mannering Colliery operations in consultation with Aboriginal stakeholders within 6 months of approval of Modification 5.

Mannering Coal Mine Modification 5 - Response to Submission

Aboriginal cultural heritage

 An Aboriginal Cultural Heritage Management Plan should be prepared for Mannering Colliery

There is an existing Aboriginal Cultural Heritage Management Plan for Centennial's Northern Holdings (ACHMP) that was prepared by RPS (2012) for Centennial Coal which includes mitigation of sites at Mannering Colliery. Consultation was undertaken with self-nominated RAPs for the Centennial Mannering Colliery operations up to 2012 but Centennial's ACHMP requires updating. An updated AHIMS search has not been provided by Delta Coal.

Delta Coal took over as owner and operator of Mannering Colliery in April 2019. There is no evidence that the ACHMP is valid for Mannering Colliery. There is also no evidence of any consultation undertaken by Delta Coal with the current self-nominated stakeholders or any of the previously registered Aboriginal parties. There is no evidence that an ACHMP for Mannering Colliery has been prepared for Delta Coal's operations.

The Biodiversity and Conservation Division recommends that a consent condition is created that requires Delta Coal to prepare an ACHMP for the Delta Coal Mannering Colliery operations in consultation with Aboriginal stakeholders within 6 months of approval of Modification 5. If consultation with the RAPs has not been continuous (six monthly or more frequently) since 2012, the consultation for the updated ACHMP should be restarted such that all current self-nominated Aboriginal stakeholders in the Local Government Area (LGA) are given the opportunity to be involved. All existing RAPs should also be given the opportunity to comments on the updated ACHMP. A current list of potential Aboriginal stakeholders for the LGA should be requested from the Division.

Recommendation 1

The Biodiversity and Conservation Division recommends that a consent condition is created that requires Delta Coal to prepare an Aboriginal Cultural Heritage Management Plan for the Delta Coal Mannering Colliery operations in consultation with Aboriginal stakeholders within 6 months of approval of Modification 5.
