**SSD 10342 – STADIUM AUSTRALIA REDEVELOPMENT, 15 EDWIN FLACK AVENUE, SYDNEY OLYMPIC PARK – PARRAMATTA LGA – EIS – REQUEST FOR ADVICE**

---

I refer to an email dated 20 September 2019 from Planning, Industry & Environment requesting Heritage Council advice on the above project (SSD 10342).

The SSDA seeks consent for the proposed redevelopment of Stadium Australia and includes alterations and modifications to the existing stadium only. The SEARs for the Project were issued on 27 June 2019.

It is noted that the site of the proposal does not include the curtilage of any State Heritage Register (SHR) items or historic archaeology. The site is in the immediate vicinity of Olympic Cauldron at Sydney Olympic Park (SHR 01839), and in the general vicinity of the Newington Armament Depot and Nature Reserve (SHR 01850), as well as a local heritage item and conservation area. It does not contain known historic archaeology. Therefore, no specific historic heritage matters were required. The general heritage requirement was for a heritage impact assessment and an archaeology assessment prepared by a suitably qualified historical archaeologist in accordance with the Heritage Division, Office of Environment and Heritage Guidelines, Assessing Significance for Historical Archaeological Sites and Relics, 2009.

Accordingly, the following document has been reviewed:

- *STATEMENT OF HERITAGE IMPACT Stadium Australia Redevelopment* prepared by Curio Projects, dated September 2019.

The above report indicates that the site has been assessed to have no archaeological potential and the proposed works are considered to have neutral heritage impact on the to the surrounding heritage items within or in proximity to the Sydney Olympic Park precinct. Based on this, the recommendations contained within Section 9.2 of the Statement of Heritage Impact are considered appropriate to manage potential impacts on historic heritage and archaeology. No further comment is provided at this time.
