RE: WESTMEAD CATHOLIC COMMUNITY – 2 DARCY ROAD, WESTMEAD REQUEST FOR ADDITIONAL INFORMATION RESPONSE

On behalf of the Proponent, The Transport Planning Partnership (TTPP) provides the documentation herein to address the Department of Planning, Infrastructure and Environment's Request for Additional Information in relation to SSD-10383.

As outlined in the RtS lodged on 23 December 2020, the base case SIDRA model was amended in-line with Bitzios' peer review. The findings of the updated base case SIDRA model indicate that amendments to the base case SIDRA model resulted in negligible impacts to the traffic modelling results. Given that impacts to the modelling results were negligible, and whilst needing to deliver the updated analysis in a timely manner, remodelling beyond the base case was deemed not to be reasonably required or necessary.

A summary is provided overleaf of documentation and SIDRA model files which have been provided to DPIE to-date, as well as the updated base case SIDRA model from 23 December 2020. Below each document title is a direct Dropbox link for where the respective file can be downloaded. It is recommended that each file is downloaded, and a local copy is saved.

We trust that the information enclosed provides DPIE with the details it requires to address its queries regarding the SSDA.
