I've received your contact details from Kasia Balsam at PTC consulting who is our traffic consultant on the Mosman High School Project.

I'm emailing today to find out some information about a disabled car park that used to be located on Belmont Road. Our original traffic investigations and proposal that was put forward in the Traffic Impact Assessment within our SSDA application was to continue to use the accessible car parking space on Belmont Road as the accessible space for the school as there is limited parking available on the school grounds and the space provided clear and level access to the Belmont Road School Entry.

During recent investigations, prompted by an RFI from DPIE, we discovered that the disabled parking space on Belmont Road has been removed at some point since the original investigation. We were wondering if you were able to provide further information as to why it was removed and whether there is any potential to reinstate it for the school to utilise when required.

Attached is a letter from PTC addressing the RFI from DPIE which shows the location of the spot on Belmont Road.
