Advice on RTS – State Significant Development modifications – Wongawilli Coal Mine – North West Mains Development (MP09\_0161-Mod-2)

Thank you for your referral uploaded to the Major Projects Portal on 3 September 2021 inviting comment from Heritage NSW on the Response to Submissions (RTS) for the above state significant development modification.

Heritage NSW has reviewed the following RTS document in our assessment:

 Wongawilli Colliery Modification 2 - North West Mains Development: Submissions Report. Prepared by EMM Sydney and dated August 2021;

## **Response to Submissions**

The RTS responded to several issues raised by Heritage NSW by providing a revised Aboriginal Cultural Heritage Assessment Report (ACHAR). We note that no known Aboriginal objects will be impacted by the proposed modification, and that the project area is assessed to contain low archaeological potential. However, concerns regarding impacts to intangible values have been raised during the process of Aboriginal consultation.

Paul Knight of the Illawarra Local Aboriginal Land Council (LALC) provided feedback to Biosis on the additional consultation table on 20 July 2021. We support the request for a stronger emphasis on documenting the intangible heritage within and interrelated with the project area. Please see Attachment 1 below for our comments in relation to the consultation process to date. These comments need to be addressed in a revised ACHAR.

Given the concerns raised by the LALC, we recommend the Aboriginal Cultural Heritage Management Plan needs to address how these intangible values will be managed and protected during the life of the project.
