Qantas Flight Training Facility
Northern Boundary Flood Impact Mitigation

Thank you for the review of our report "Qantas Group Flight Training Centre Flood Impact Assessment" dated 12/08/2019. Council's review of the report (via email 16/08/2019) notes there is an increase in flood levels of up to 60mm along a part of Qantas' northern boundary as a result of the above project, and that:

"Future development on the adjoining northern lot would be impacted by the increase in flood level and this impact should be considered and mitigated if possible."

As part of the detailed design process, it is anticipated that this impact will be able to be suitably mitigated. We have undertaken an initial investigation on lowering the access road / overland flow route around the car park by up to 100mm. Initial modelling shows this results in no increase in flood levels on the northern boundary.

This matter could be suitably addressed as part of a condition of consent. The following wording is proposed:

"Plans demonstrating no additional impact on adjacent properties to the north of Lot 133 DP 659434, as a result of overland flow paths are to be provided to the Certifier prior to issuance of any Construction Certificate for the car park."

Please see comments below from Council's officers:

### Flooding:

Staff have reviewed the revised flood assessment report by Enstruct and the external peer review of the flood model.

- The peer review of the flood model was completed by Catchment Simulation Solutions (CSS) on 06/08/2019. CSS confirmed that TUFLOW model updates (Enstruct) were reasonable and reflect modern best practice.
- $\bullet \ \ \text{The proposed finished floor level is acceptable and includes the necessary freeboard above the 1\% AEP flood level.}$
- It is noted that the proposal will have an impact to the adjacent property (along the northern boundary of the site).
- The Flood impact map "1% AEP Event-Revised" shows the flood level will be increased by 30mm to 60mm and more in some locations. The velocity and flood hazard will also increase in these locations. The report notes the adjacent development to the north is built above the modelled height of the flood waters. Future development on the adjoining northern lot would be impacted by the increase in flood level and this impact should be considered and mitigated if possible.

#### WSUD

Please note that Council does not have access to the software required to open the file provided by enstruct.

It is noted that whilst the report includes the water quality requirements contained in the Botany Bay DCP 2013, it does not provide details of an assessment

Sydney Water should be consulted on the water quality report, as the final stormwater discharge point is the existing Sydney Water Channel which runs east/ west across the site.

### Flooding:

Council notes that this report does not include a response to Council's previous comments regarding the external peer review of the TUFLOW model and the impact of the proposed fill in the northern car park area.
