**RE: REQUEST FOR ADDITIONAL INFORMATION
FORT STREET PUBLIC SCHOOL (SSD-10340)**

We write in response to the Department of Planning, Industry and Environment's (DPIE) request for additional information relating to the development application for the Fort Street Public School (SSSD-10340).
