Request to waive requirement for BDAR under Section 7.9(2) of the Biodiversity Conservation Act 2016 – Westmead Catholic Community Education Campus, 2 Darcy Road, Westmead – SSD 10383

I refer to the request from Cumberland Ecology to waive the requirement for a biodiversity development assessment report (BDAR) to be submitted with the proposed State significant development (SSD 10383) for the Westmead Catholic Community Education Campus.

I have reviewed the information provided by the applicant in the BDAR waiver application dated 18 October 2019 and determined that the proposed development is not likely to have any significant impact on biodiversity values. The application therefore, does not need to be accompanied by a BDAR.

Westmead Catholic Community Education Campus (SSD-10383) - Request to waive the need for a Biodiversity Development Assessment Report under the

Biodiversity Conservation Act 2016

I refer to your request submitted on 30 October 2019 for the issue of a waiver for the requirement for a Biodiversity Development Assessment Report (BDAR) to be submitted as part of the state significant development (SSD) application for the Westmead Catholic Community Education Campus (SSD-10383).

Section 7.9(2) of the Biodiversity Conservation Act 2016 (BC Act) provides the following in relation to an application for SSD:

"Any such application is to be accompanied by a biodiversity development assessment report unless the Planning Agency Head and the Environment Agency Head determine that the proposed development is not likely to have any significant impact on biodiversity values."

The authority of the "Planning Agency Head" to determine whether a proposed development is "not likely to have any significant impact on biodiversity values" has been delegated to Directors within the Planning and Assessment Division of the Department.

Accordingly, I have reviewed the application of the test of significance under sections 1.5 and 7.3 of the BC Act and clause 1.4 of the Biodiversity Conservation Regulation 2017 and considered the information provided in the letter prepared by Cumberland Ecology dated 18 October 2019. I have determined that the development is not likely to have any significant impacts on biodiversity values and that the application does not need to be accompanied by a BDAR. A waiver under section 7.9 is therefore granted for the proposed development (being the Westmead Catholic Community Education Campus (SSD-10383)).

The delegated "Environment Agency Head" in the Environment, Energy and Science Group of the Department has also granted a waiver in a letter dated 19 November 2019 and a copy of that letter is attached.

Please note that the waiver is issued in respect of the proposed development detailed in the Secretary's Environmental Assessment Requirements submitted on 30 October 2019. Amendments to the development may require a further waiver to be sought and issued.
