I refer to the Department's below email of 9 September 2021 regarding the Supplementary Response to Submissions (SRtS) and an Amended Proposal, further addressing the comments and matters raised during the exhibition of the Environmental Impact Statement (EIS) for Westmead Catholic Community Education Campus for 'Primary school with capacity for approximately 1,680 students, new Parish church, early learning centre, multi-storey car park and drop off zone and landscaping' at 2 Darcy Road, Westmead (Lot 1 DP 1095407, Lot 1 DP 1211982) in the City of Parramatta Local Government Area (LGA).
