
1 Introduction and Purpose

This document describes the stakeholder consultation for the Liverpool Health and Academic Precinct (LHAP) Main Works project. A framework was designed to capitalise on the opportunities to engage with precinct partners and deliver on the broader ambitions for the Precinct. Accordingly, it sets out the minimum elements of stakeholder engagement and communications planning which has been undertaken to date. It is underpinned by a communications plan and clear key messaging structure which, combined, will facilitate understanding and support for the project. The stakeholder engagement framework is cognisant of the related governance structure for the LHAP project, and aims to deliver key messaging to stakeholders at appropriate times in decision making processes as the project progresses.

2 Precinct Engagement Plan

2.1 Background and scope

The LHAP Project aims to build on the existing health, education, research and business offerings, and support the continued growth of the knowledge sector, economic output and jobs in Liverpool, and will facilitate the cross-fertilisation of ideas between these sectors. It will provide an anchor point to support NSW Government and Liverpool Council's aspirations for urban renewal and growth in the Liverpool area, and South Western Sydney.





3 Consultation

The following consultation has been undertaken to date for the Liverpool Health and Academic Precinct Main Works with the following stakeholders:

- Liverpool City Council;

- School Infrastructure NSW;
- Hospital user groups; and
- The local community.

The following sections provide details of consultation undertaken with the above stakeholders.

3.1 Government Architect NSW

Health Infrastructure (HI) presented the LHAP Main Works Master Plan to the Government Architect's Office on 4 September 2019. Refer to Appendix A for notes on meeting 1.

A follow up meting to present the LHAP Main Works proposal to the Government Architect's Office was held on 23 October 2019. Refer to Appendix B for notes from meeting 2.

Meeting 3 consisted of a follow up presentation to the Government Architects Office on 4 December 2019. Refer to Appendix C for notes from meeting 3.

3.2 Liverpool City Council

A number of meetings have been undertaken with Liverpool City Council (LCC) in relation to the project. The table below provides a summary of the meetings held.

3.4 Service Providers

The project team has liaised with relevant service providers to discuss requirements for the LHAP Main Works.

Electrical - Endeavour Energy

As part of the Civil Infrastructure Works, the LHAP team have coordinated the existing and proposed site electrical loads with Endeavour Energy to ascertain where the new electrical load will be supplied from. The LHAP HV level 3 team has lodged a "Technical Enquiry" with Endeavour Energy and received advice on the current arrangement.

The LHAP Level 3 design team are currently working with the Civil infrastructure Works contractor to complete the "Method of supply offer" and acquire the design information package from Endeavour Energy which will then



be used to complete the Level 3 Designs for their approval. This work will all form part of the Civil Infrastructure Works being carried out prior to the Main Works.

Sydney Water

The project team submitted a Section 73 Feasibility to Sydney Water on 7 May 2018 for the assessment of the capacity of their water main and advise if any potential upgrades are required.

Additionally, multiple pressure and flow enquiries have been submitted to assess the capacity in the system.

Sydney Water responded to the Section 73 Feasibility on 19 October 2018 and advised that there is adequate capacity in the 300mm water main for connection.

3.5 Local Aboriginal Community

The hospital held meetings with the Gandangara Local Aboriginal Land Council (Gandangara LALC) on 14 June 2019 and 27 November 2018. A brief outlining the LHAP redevelopment progress was also issued to Gandangara LALC in February 2019.

The project team held an archaeological survey of the LHAP project area with the Gandangara LALC on 25 November 2019.

As part of the Aboriginal Cultural Heritage Assessment process, Aboriginal stakeholders were provided with information about the proposal and the cultural heritage assessment process, including the methodology for collecting information on cultural heritage significance.

Responses were received from Murra Bidgee Mullangari Aboriginal Corporation, A1 Indigenous Services, Gandangara LALC, Darug Custodian Aboriginal Corporation, Kamilaroi Yankuntjatjara Working Group (Phil Khan), Darug Aboriginal Land Care (Des Dyer), and Kawul Cultural Services. All responses received were supportive of the proposed ACHAR methodology.

3.6 Fire and Rescue

The Project Team has met with Fire Brigade 25 September 2019 and provided a presentation of FEBQ Requirements and discussion of fire issues.

A meeting was held with NSW Fire and Rescue on 3 March 2020 to discuss the impact of works on current certifications.

3.7 Liverpool Innovation Precinct

The Project Team has provided high level project update to the Liverpool Innovation Precinct on 14 August 2019.



3.8 School Infrastructure, Liverpool Girls High School and Liverpool Boys High School

A number of meetings have been undertaken with School Infrastructure in relation to the LHAP and Liverpool Education Precinct (LEP) projects. Consultation has also been undertaken with Liverpool Girls and Boys High Schools which are adjacent to LHAP. The table below provides a summary of the meetings held.

3.9 Hospital User Groups

The Project Team has completed an average of three rounds of Feasibility Project User Groups (PUGs), covering Models of Care and producing Schedules of Accommodation. This was followed by a further 3 rounds of Schematic Design PUG consultation. Meetings focus on the individual needs of specific departments such as Emergency and Inpatient Units and are supported by broader consultation groups which focus on Overarching Principles, Engineering Services and Back of House servicing. The PUGs were held between July 2018 and February 2020. PUG attendees included clinical and support staff, as well as community advocates to establish a broad range of experiences and viewpoints in to the development of the Schematic Design.

Generally the design and approach to the project is supported, in particular:

- Integration of wayfinding and landscaping

The following commentary provides advice and recommendations for the project:

- Provide further detail of and illustrate the relationship between the carpark and the school open space to the north;
- The façades of the building present an opportunity for incorporation of an architectural artwork. Recommendation is made to engage in consultation with an Indigenous artist to inform the architectural solution;
- Illustrate the proposed pedestrian journey from the carpark to existing and future hospital facilities;
- Integrate weather protection for accessible parking spaces located at ground level.

Dear John,

Thank you for the opportunity to review the above project at an early stage at the SDRP session held on 23.10.19.

The masterplan analysis and rationale of the project are generally supported, in particular:

- Creation of public landscaped open spaces including retention of existing significant trees;
- Creation of the internal street as the principal organising element of the ISB:
- Improvements to vehicle circulation and wayfinding, including traffic calming strategies;
- Comprehensive traffic study currently underway;

The following commentary provides advice and the matters raised should be discussed at the next SDRP:

- Reinforce the idea of the landscape as driver of the masterplan by giving prominence to and privileging the proposed open spaces;
- The main open space north of the Caroline Chisholm building should be further developed with a larger landscape footprint, minimising drop-off areas and hard paving. Creation and maintenance of this open space is strongly recommended to futureproof the site in the context of future development envisioned to the east of the Caroline Chisholm building.
- Further develop the creation of a significant landscaped link between the hospital entry and the visitor carpark structure, privileging pedestrian amenity along this link;
- Tower elements should incorporate permeability and transparency to the facades, sunshading and façade treatments to respond to orientation, and treatment of the plant level to reduce the bulk and scale. Consider the inclusion of balconies / breakout spaces in the IPUs that can contribute to patient amenity, improve tower façade articulation and allow for overlooking to and activation of the streets;
- Confirm the provision of street trees, awnings and other treatments along Goulburn St to improve the public domain and break down the scale of the built forms;



- Clarify the extent and location of internal courtyards at podium level including landscape treatments;
- Explore how a narrative of health and healing specific to the community can be expressed through the built and landscaped environment;
- Clarify cycle routes including connection to both train stations and within the hospital campus;
- Illustrate the relationship of hospital to other buildings / sites being part of the LIP.

Dear John,

Thank you for the opportunity to review the above project at the SDRP session held on 04.12.19.

The team's presentation clearly identified issues that have been addressed and issues that remain outstanding. The presentation by the Landscape Architects is appreciated as it helped in the understanding of the project.

The following commentary provides advice and the matters raised should be discussed at the next SDRP:

Landscape

- The focus on landscape as a restorative element in the health precinct is commended and should be prioritised. Further detail should be provided on the proportion of soft to hard landscape, noting a metric of 70% soft to 30% hard landscape was targeted.
- While the inclusion of an Indigenous Courtyard is important it is only a singular gesture of how the landscape can incorporate Aboriginal Cultural Heritage into the broad context of the project. Provide details of how the connection to Country will be made evident throughout the hospital campus: for example, using landscape, materials, plant selection, art installations/murals, naming, wayfinding devices, paving, colour, texture and so on.
- Illustrate the link between the hospital entries and the visitor carpark structure, indicating landscaping and pedestrian amenity along this link, including shading appropriate to orientation and separation of pedestrians from vehicular traffic.
- Investigate the consolidation of landscape areas north of the Caroline Chisholm building, including level access to lawns and clear circulation pathways minimised to privilege the landscape areas
- The drop-off zone in the Forbes St courtyard should be minimised as far as possible to increase usable open space.
- Access should be provided to rooftop courtyards for staff and/or patients and/or visitors.
- Investigate a more organic approach to the organisation of the landscape which could act as a counterpoint to the regular vertical patterns of the built forms.



 Clarify how the various public landscape areas will accommodate different cultural groups with sufficient space and amenity, noting open and landscaped spaces will be used for respite by staff, patients, visitors and the general public.

Buildings

- Tower elements should incorporate permeability and transparency to the facades, sunshading and façade treatments to respond to orientation, and treatment of the plant level to reduce the bulk and scale. Consider the inclusion of balconies / breakout spaces in the IPUs that can contribute to patient amenity, improve tower façade articulation and allow for overlooking to and activation of the streets.
- The podium requires further refinement to clearly differentiate its scale, materiality and articulation from the tower elements.
- Investigate the introduction of horizontal elements at podium level to provide relief from the vertical treatment of tower facades.
- The window boxes along the podium are a useful articulation device but require further development to provide deeper brick reveals and appropriate shading to glazed areas. The use of obscure or black glass is not supported.
- The use of brickwork in general is supported but requires further refinement in its application to integrate with the overall architectural expression of the buildings rather than as an applied surface treatment.
- Provide information relating to sustainability and ESD strategies including how these strategies have informed the design of built forms and façade treatments. Include targets for energy and water efficiency and demonstrate how these have been met.
- Clarify cycle routes including connection to both train stations and within the hospital campus.
- Illustrate the relationship of hospital to other buildings / sites being part of the LIP.

Please refer to the design package requirements form for information on materials to be provided at the next SDRP. Materials provided should also include:

- 3D views to illustrate internal amenity.
- Details of consultation with SINSW and Liverpool Council and agreed initiatives to achieve integrated public benefits.
