Please provide the following submission;

Ausgrid has reviewed the EIS and in particular Appendix 16 (Infrastructure report).

We note that Ausgrid has 33,00V cables buried along Percy St. As such suitable precautions should be adopted by the development regarding the construction and ongoing operation of the facility in the vicinity of these cables.

The proponent should obtain plans through DBYD and refer to Ausgrid Network Standard NS156 regarding working near these cables

Ausgrid notes the development requires for the decommissioning and removal of two existing substations and for the design and construction for new substations to supply the new development's load requirements. Ausgrid recommends the proponent to progress the connection application to Ausgrid as soon as possible.
