Here is Sydney Airport's response to Planning NSW Request for SEARs comments:

Under 4.3 – height of buildings of the scoping report it states "The proposed development generally complies with the 70 metre height limit for the site".

I have made the assumption that the 70 metres is above ground height.

The approx. maximum height of the proposed development would then be 90m AHD.

The Obstacle Limitation Surface over the site is 51m AHD.

Any such proposed development would be subject to assessment & approval By the Federal Department of Infrastructure, Transport, Regional Development and Communications under the - Airports (Protection of Airspace) Regulations 1996
