for a Biodiversity Development Assessment Report under the *Biodiversity*

I refer to your correspondence dated 29 October 2021 requesting the issue of a waiver from the requirement for a Biodiversity Development Assessment Report (BDAR) to be submitted as part of the state significant development (SSD) application for the Macarthur Medical Research Centre (SSD-17491477).

Section 7.9(2) of the *Biodiversity Conservation Act 2016* (BC Act) provides the following in relation to an application for SSD:

"Any such application is to be accompanied by a biodiversity development assessment report unless the Planning Agency Head and the Environment Agency Head determine that the proposed development is not likely to have any significant impact on biodiversity values."

The authority of the "Planning Agency Head" to determine whether a proposed development is "not likely to have any significant impact on biodiversity values" has been delegated to Directors within the Planning and Assessment Division of the Department.

Accordingly, I have reviewed the application of the test of significance under sections 1.5 and 7.3 of the BC Act and clause 1.4 of the Biodiversity Conservation Regulation 2017 and considered the information provided in the report prepared by Biosis dated 19 October 2021. I have determined that the development is not likely to have any significant impacts on biodiversity values and that the application does not need to be accompanied by a BDAR. A waiver under section 7.9 is therefore granted for the proposed development (being the Macarthur Medical Research Centre (SSD-17491477)).

The delegated *Environment Agency Head* of Environment, Energy and Science Group of the Department (EESG) has also granted a waiver in a letter dated 9 November 2021 and a copy of that approval is attached.

This waiver is issued in respect of the proposed development detailed in Western Sydney Universities' Request for Secretary's Environmental Assessment Requirements – for the proposed Macarthur Medical Research Centre at Campbelltown Hospital Campus, dated 12 May 2021. Amendments to the development may require a further waiver to be sought and issued.

SCHEDULE 1 – Description of the proposed development

The proposed development is the Macarthur Medical Research Centre at 100 Parkside Crescent, Campbelltown, New South Wales (Lot 6 DP 1058047). The proposal seeks consent for the demolition of the existing helipad and associated walkways and construction of the new research centre, including associated landscaping and infrastructure works. The proposal would clear 0.22 ha of identified exotic vegetation.
