In principle there is no objection to this modification, however, the information provided did not allow the City to make a full assessment. Based on the information provided it is not clear whether there are street trees, power poles, traffic lights etc. on this footpath that may require a certain setback of the new awning structure.

Can I ask that in any assessment that the Department give consideration to Section 3.2.4 of the Sydney DCP 2012 (link provided below). In particular, minimum setback requirements from the kerb for any new awnings.
