- 4. Delete all references to:
 -) "NOW", and replace with "DPIE Water"; and
 - ii) "OEH", and replace with "BCD".
- In the Note to condition 5 of Schedule 2, delete "both the Secretary and the Deputy Secretary, Resources and Energy" and insert "the Secretary and the Resources Regulator".
- 6. In condition 3 of Schedule 3, add the following row to Table 3:

Water truck access to the Bowens Road Water Fill Point	7 am to 6 pm, Monday to Saturday

7. In condition 18 of Schedule 3, insert the following after "privately-owned land.":

"Note:

"Reasonable and feasible avoidance measures" includes, but is not limited to, the operational requirements in conditions 23 and 24 to develop and implement a real-time air quality management system that ensures operational responses to the risks of exceedance of the criteria."

- 8. In the Notes to Table 6 of condition 18 of Schedule 3, delete Note "e",
- 9. In condition 20(c) of Schedule 3, delete "20" and replace with "19".
- 10. After condition 30 of Schedule 3, insert:

"Offsite Water Transfer

- 30A. The Applicant may allow a public authority to collect and transport water offsite by road:
 - a) where this water is intended for use for a public purpose, and
 - b) up to a maximum rate of 25 road registered water trucks per day.

Notes:

- The transport and use of water by the public authority may be subject to separate regulatory requirements, including processes under Part 5 of the EP&A Act, and relevant controls, restrictions and/or exemptions under the POEO Act.
- This condition does not restrict or affect water that may be taken under the provisions of the Rural Fires Act 1997."
- 11. In conditions 53 and 55 of Schedule 3, delete "Deputy Secretary, Resources and Energy", and replace with "Resources Regulator".
- 12. In condition 55(c) of Schedule 3, delete "DRE" and replace with "DRG".
