- 3. In Table 6 in condition 1 of Schedule 4:
 - (a) in the row for "1st and 2nd Order streams", after the word "EIS", insert the words "and SEE (Mod 4)";
 - (b) in the row beginning "Aquatic and riparian ecosystems", after the words "Wyee Creek", insert the words ", Tobins Creek";
 - (c) in the row beginning "Steep slopes and rock outcrops", after the word "EIS", insert the words "and SEE (Mod 4)"; and

 - (b) delete the paragraph following the word "Secretary" and replace with:

"Within 4 weeks of conducting any such review, the Applicant must advise the Secretary of the outcomes of the review, and provide any revised documents to the Secretary for review and approval."

In condition 9 of Schedule 6, delete the words "Guidelines for Establishing and Operating Community Consultative Committees for Mining Developments (Department of Planning, 2007, or its latest version)" and replace with "Community Consultative Committee (CCC) Guidelines for State Significant Projects (Department of Planning, 2016) or its latest version".
- 7. In condition 13 of Schedule 6, after the word "commission", insert ", commence".
- 8. In condition 14 of Schedule 6, delete the full stop and insert ", and a timetable for the implementation of any measures proposed to address the recommendations".
