ORGANISED CRIMINAL GANG MANAGEMENT PLAN

Future Music Festival 2012 Development Consent:

Minister for Planning and Infrastructure and Trustees have given approval for Development Consent for Future Music Festival 2012 for a capacity crowd of 45,000.

The Police have asked that the ATC supports the success of the Future Music Festival by settling conditions that allow the Police to exclude members of known criminal gangs:

- a) Section 37 of the Australian Jockey and Sydney Turf Clubs Merger Act 2010 (NSW) permits the Australian Turf Club Limited (ATC) to refuse admission to, or expel a person from, any part of Randwick Racecourse (or cause a person to be refused admission or expelled) if there are reasonable grounds for believing that the person's presence on the Racecourse would be undesirable in the interests of the public using the Racecourse.
- b) officers of the Eastern Beaches Local Area Command of the NSW Police Force (Police) have on several occasions informed members of the ATC management and executive that members of certain outlaw motorcycle gangs (OMCG) or known criminal gangs are likely to attend the Future Music Festival 2012 event on 10th March 2012 at Randwick Racecourse. The police have emphasised their concerns for security at the Future Music Festival as a result of a real or perceived risk. The ATC and police continue to be in consultation about this matter.
- c) ATC personnel are not able to identify members of MCG or known criminal gangs, their gang colours or associated clothing, jewelry or accessories and would need the Police to do so before any security measures could be taken.
- d) Clause 9 of the Randwick Racecourse By –law 1981 requires a person hiring any part of the Randwick Racecourse premises to bide by any order of the ATC or officer authorised by the ATC.

Management seeks the Board to tesolve:

- i) in accordance with section 37 of the Australian Jockey and Sydney Turf Clubs Merger Act 2010 (NSW) the Orief Executive of the ATC is requested to direct the police, on behalf of the ATC, to refuse admission to all members or associates of any outlaw motorcycle gangs identified by the police, and to expel such persons from the Randwick Racecourse premises on the day that the Future Music Festival is held at the Randwick Racecourse in the interests of the public and other persons attending or working at the Future Music Festival; and
- ii) in accordance with clause 9 of the Randwick Racecourse By-law 1981, the promoters of the Future Music Festival 2012 be directed by the Chief Executive of the ATC, or his nominee, to abide by the direction made by the ATC in the resolution set out in paragraph 1 above by refusing admission to all members or associates of any outlaw motorcycle gangs identified by the police from entering the Future Music Festival 2012 at the Randwick Racecourse.
