Modification Description

- Enable the transfer of coal from the Lidsdale Rail Siding back to the Springvale Coal Services Site (SCSS) using the existing overland conveyor system that operates between the Lidsdale Rail Siding and the Springvale Coal Services Site; and
- Increase the volume of coal that can be received at the SCSS from other sources (other than the Springvale Mine and Angus Place Colliery) from 1 million tonnes per annum (Mtpa) to 1.5 Mtpa.

How is the modification substantially the same as the original development?


The proposed modification constitutes a minor change to an existing approved Project. . The proposed modification will not change the core objective of the Project being a project to facilitate the receipt, handling and processing of coal from the Springvale Mine, Angus Place Colliery and other Centennial Coal operations, and the transportation of this coal to local power stations. As such, the project will remain substantially the same as originally approved.
