1. Existing Agreements

There are two existing Safety Interface Agreements (SIA) between John Holland Rail (JHR), as the Rail Infrastructure Manager (RIM) for Country Rail Network (CRN) and:

(i) Centennial Coal Infrastructure Pty Limited - as the RIM for the Charbon Colliery Balloon Loop Private Siding, dated 31 July 2018

(ii) Centennial Airly Pty Limited - as the RIM for Airly Coal Balloon Loop Private Siding , dated 13 December 2018.

Both SIAs relate to the interfaces between the Charbon and Airly Mine's private rail loops and CRN's main rail line, specifically the Wallerawang to Kandos section (referred to as the Wallerawang-Gwabegar Railway in both Airly MOD 2 and Charbon MOD 1 SEEs). The SIAs provide surety regarding management of risks to the environment posed by the operations of the private rail loops on any potential or actual impacts on the JHR operational corridor.

There are no expiry dates on the SIAs.

2. EPL Requirements

Both SIAs note that Centennial's operations should not pose potential or actual risks to the continuation of JHR's EPL.

It is noted:

- The operations of the Charbon and Airly private rail loops (within the development consent boundary) are regulated by the respective consent noise and air quality criteria
- Noise assessments undertaken in Airly MOD 2 / Charbon MOD 1 SEEs, and discussed further in the Responses to Submissions (RTS), confirm that the operation of the one water laden train on CRN's Wallerawang-Gwabegar Railway between Charbon and Airly mines will be compliant with the noise criteria on JHR's EPL 13421.

3. Consultation

The SIAs identify communication and dispute resolution protocols between JHR and the Centennial Coal subsidiaries noted in (i) and (ii).

As noted in the RTSs, consultation with JHR is planned in the near future, and this may occur within the next fortnight and prior to the operation of the water laden trains. At that consultation meeting, Centennial representatives will discuss whether the water laden trains can be operated under the existing SIAs or if the existing SIAs need to be amended.
