Description: Modification to amend Schedule 4 Condition 12 of SSD 5594 to: a) remove the requirement to Meet limits for salinity of 700 (50th percentile), 900 (90th percentile) and 1000 (100th percentile) $\mu\text{S/cm}$ EC by 30 June 2017 b) defer to 30 June 2019 the requirement to Eliminate acute and chronic toxicity from LDP009 discharges to aquatic species by 30 June 2017, with acute toxicity defined as >10% effect relative to the control group and chronic toxicity defined as >20% effect relative to the control group.
