This letter responds to the NSW Planning & Infrastructure letter with reference number SSD 12_5676 & SSD 12_5677.

The letter requested that an assessment of the acoustic impact from major events and any mitigation measures proposed to attenuate Stage 1A and 2 buildings from impacts from major event noise and submission of a sediment and erosion control for Stage 1A.

Internal Noise Criteria

The internal noise levels shall comply with the requirements of Australian Standard AS2107-2000 and Green Star Criteria which have been presented in the previous acoustic reports and repeated below:

Building Services Design

- within the entire base building general office space, noise from the building services does not exceed 40dBA L_{eq}

Overall Building

 where within the base building office space, the sound level does not exceed 40dB(A) L_{eq} (assuming open plan offices).

Noise Mitigation Solutions

Noise intrusion from typical major events within Olympic Park and Stadium have been reviewed based on the noise data above into the buildings of Stage 1A and Stage 2 has been reviewed and findings are below:

• Acoustic treatments recommended in the previous acoustic reports are sufficient and do not need to be upgraded. Internal noise levels within Stage 1A and Stage 2 will fully comply with the requirements of AS2107-2000 and Green Star Criteria with the recommended acoustic treatments in Section 4.6 of previous acoustic reports provided by this office with reference number: 20101130.2/1807A/R0/GW.
