My family moved to Elderslie in 2012 for the great location, employment opportunities and a great lifestyle for ourselves and our family. With a selection of new and established schools, Campbelltown TAFE, the University of Western Sydney, Industrial Estates, Employment Zones, Town Centres and Sporting Facilities close by it was the ideal place to settle down for the long-term and raise a family.

Recently we became aware of the proposed expansion of AGL Coal Seam Gas drilling, mining and 'Fracking' or 'Fracturing' under our homes, schools, workplaces, football fields, cricket ovals, leisure centres, our community halls, our churches, our petrol stations, our overhead bridges, open spaces and catchment areas.

These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply concerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the future,

having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not been adequately assessed. While AGL claims that the *geology of the Sydney Basin is well known*, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that it does not know where the aquifers here run to but *probably Sydney Harbour*. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will continue to produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. The risks and potential costs to the community do not justify this, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.







Please accept this as a submission on the Camden Gas Project Stage 3 Northern Expansion which is currently on public exhibition. I object to AGL's project application 09_0048 to drill for coal seam gas in Western Sydney.

Please put the health and wellbeing of the people of Greater Western Sydney above the profits of AGL who plan to expand their gas field around and under people's homes and businesses.

I urge you to reject the proposal by AGL to drill 66 new coal seam gas production wells on the grounds that:

- Reports from Queensland and overseas show that there are serious risks to air quality and human health from unconventional gas drilling. However there have been no detailed studies done to quantify those risks especially in urban areas. The people of Camden and Campbelltown should not be treated like guinea pigs in a coal seam gas experiment.

- People's homes should not be undermined by coal seam gas drilling without their knowledge or permission.

- Homeowners face declining property values within and adjoining coal seam gas fields with some estimating house values may fall up to 30%.

- The integrity of gas wells can't be guaranteed and research from gas fields in Queensland and the US has shown many fail in their first few year. This will leave the community to deal with the impact of leaking wells on air quality and local water supplies.

- New research from Southern Cross University on methane gas leaks from coal seam gas fields has not been considered in the proposal. AGL has not conducted these studies to account for methane leakage on their existing coal seam gas wells.

- Despite research from the Queensland and the US suggesting ground water contamination and gas leaks from fracking, the proposal by AGL will allow fracking.

- The impacts of horizontal drilling have not been adequately considered in the Environmental Assessment.

- There are alternatives to coal seam gas, including renewable energy which can offer energy security without the unacceptable environmental and health risks posed by coal seam gas extraction.

- It is my will that CSG aka fracking stop immediately

- It is my will that the politicians that support and refuse to stop CSG are wholly accountable and all their estates be liquidated to repair the damage caused to untold generations of Australians by CSG contamination of underground water tables including the great artesian basin. I also submit that their family trees be followed and assets of relatives be liquidated to repair said water tables until the damage has been repaired.

My family moved to......(SUBURB NAME) in 2005 for the great location, employment opportunities and a great lifestyle for our 3 children. With a selection of new and established schools, Campbelltown TAFE, the University of Western Sydney, Industrial Estates, Employment Zones, Town Centres and Sporting Facilities close by it seemed a perfect place to settle down for the long-term and raise a family.

Unfortunately, my youngest son has developed asthma since we moved here. We did not realise that the air quality is deceptively poor - in fact, the worst polluted atmospheric Airshed in Greater Sydney. If we can't breathe here, we can't live here. Air Quality is the critical health issue for all of us out here.

Recently we became aware of the proposed expansion of AGL Coal Seam Gas drilling, mining and 'fracing' or 'fracturing' under our homes, schools, workplaces, football fields, cricket avals, leisure centres, our community halls, our churches, our petrol stations, our overhead bridges, open spaces and catchment areas.

If we had known about the AGL-CSG expansion we would have avoided the area and a \$450,000 life-time mortgage in a suburb destined for degrading and devaluing. It doesn't make any sense at all !

Fracing' is actually "FRACTURING" - breaking and cracking the sub-surface under us. AGL falsely compares its 'fracing' chemistry is to 'harmless' products on a laundry shelf, when in fact the real chemicals in vast quantities are highly volatile producing toxic gaseous and particulate emissions to earth, water and air. AGL Consultants have been grossly dishonest and deceitful in their minimal description of 'fracing' processes.

Despite misleading media reports AGL-CSG will definitely 'frac" under us, AGL's intentions are very clear in both their 2010 ENVIRONMENTAL ASSESMENT at Chapter 4.2 and in the 2012 MAIN REPORT at Chapter 3.4.

We are not against mining at all. However, introducing toxic and dangerous AGL Coal Seam Gas mining under our existing permissible land use zones of established and populated communities is totally inappropriate in every respect, and absolutely beyond our belief.

AGL conceals its toxic 'fracing' chemistry behind claims of 'commercial confidentiality'. We do know that AGL use concentrated acids and biocides among a huge list of chemical cocktails triggering volatile chemical reactions in coal and sandstone seams underneath our homes and schools. The fact that AGL will not disclose its 'fracing toxicology' is absolutely absurd – a nightmare with disastrous health and environmental consequences.

Mining is the most accident riddled industry in Australia. Mixing mining and untested chemistry under our homes as we sleep is a disastrous formula for major critical incidents. We don't need the threat of disaster, totally 'fracing' our dreams into nightmares, for over 20 years of sleeps, after busy days at school and work.

Do you and Minister Hazzard fully comprehend the potential implications of cumulative long-term toxic emissions to our earth, our water and breathing atmosphere? Have your planning experts fully analysed AGL's documents to find the serious omissions and false 'conceptual modelling' promoted as acceptable science ?

We understand that AGL-CSG drilling, mining and 'fracing' under our populated and established communities is totally new to urban Australia. Is South Western Sydney AGL's and the O'Farrell Government's test case to expand toxic mining under metropolitan Sydney?

If you proceed with AGL's proposal you will be opening the pathway for a massive class action against all the decision makers, back door dealers and promoters of this toxic and hazardous industry.

We are not your "westie lab rats". We are not your experiment in 'social injustice' and socio-economic and environmental degradation? Don't do it in anyones' backyard. We know you'll never allow it in yours !

I object to AGL's project application 09_0048 to mine for coal seam gas (CSG) in Campbelltown and Camden. The key reasons for my objection are stated below.

I am concerned that CSG mining is a technologically-evolving industry whose impacts have not been independently and scientifically fully researched and remain largely unknown. This view is supported by professional organisations and academics in evidence to the NSW Upper House and Senate Inquiries into Coal Seam Gas Mining in 2011 and by subsequent research here and overseas. We have had to rely on the industry for much of our information when the industry has a vested interest in the outcome. AGL is no different. It claims that the Camden Gas Project has been safely operating for 10 years. Yet we understand that impacts on groundwater and air quality have not been adequately monitored, and while AGL has been operating under an Environmental Protection Licence (EPL No. 12003), it has been allowed to self-monitor its compliance, self-investigate incidents and self-report such that we do not know what true impacts it may have had. Third party consultants and external laboratories that are engaged and paid for by the industry are not *independent*. Nor is any funded or co-funded research by the CSG mining industry. These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply oncerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the future, having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic

Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not oeen adequately assessed. While AGL claims that the *geology of the Sydney Basin is well known*, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that it does not know where the aquifers here run to but *probably Sydney Harbour*. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

I acknowledge that my name will appear on my submission when publicly exhibited.

My family and I moved to Kearns in August 2005 to enjoy the semi rural lifestyle with large yards, parks and the rolling Scenic Hills. After travelling the country for 15 years with the Defence Force we chose to settle down in Kearns which we believed to be the perfect environment to raise our two daughters.

We are concerned that our family and lifestyle will be impacted by the proposed expansion of AGL's Coal Seam Gas drilling, mining and fracturing under our home, our children's schools, parks and surrounds.

Clearly we would not have chosen to settle down in Kearns to raise a family with subsequent years of schooling in a suburb and surrounds that was being exposed to the AGL CSG expansion. We are now fully intertwined with the community, locals, neighbours and other friends and we do not look forward to the potential destruction of our world as we know it.

The current available literature indicates that AGL will be fracing or fracturing in our area which will have an immediate impact below our property and the community surrounds, AGL's intentions are very clear in their 2010 Environmental Assessment Chapter 4.2 and in their 2012 Main Report in Chapter 3.4.

Given that there is much anecdotal evidence with respect to the by-products and hazards that can occur to flora, fauna, ground water and the rest of the environment we believe that there needs to be more rigorous and responsible research and assessment as to the ramifications and long term affects of coal seam mining before conducting and implementing coal seam mining.

An example of previous initiatives without judicious independent assessment could be the James Hardy asbestos catastrophe, where indications that it was not completely safe were ignored to the detriment of the communities, taking lives of men, women and children. We are therefore concerned of the potential risks of uncontrolled toxic particle emissions to the earth, air and water that could threaten our community given the incomplete physical and chemical analysis of the coal seam gas fracing process.

The threat of long term damage to water aquifers, water tables, creeks, rivers and catchment areas is a catastrophic risk to be taken for any financial venture; little own, a business venture like AGL-CSG which has no direct financial benefit to the communities under threat. A risk of any proportion should involve input from all relevant stakeholders, given the community that resides in the area in question will be affected in the short and long term; the community should have the opportunity to vote for or against such an environmentally reckless operation.

My family and I are concerned that the NSW State Government has not tendered for the conduct of an independent critical analysis of the AGL-CSG proposal.

A response to Campbelltown Council from Chris Hartcher MP NSW Minister for Resources & Energy on behalf of the NSW Government (IM12/31334 MF12/7521) dated 10 October 2012, was quite condescending in its lack of support to the council proposal for a moratorium on coal seam gas activities until "conclusive evidence emerges" in relation to its effect. To state that "Exploration is a key step in developing the evidence to provide necessary detail on the likely effects of potential future activities and to develop information on the available resources and environment. Without exploration, there will not be an opportunity to develop the necessary evidence to make informed decisions in relation to coal seam gas activities" means the following:

- the NSW Government now admits that they don't have the necessary evidence and are therefore making an "uninformed decision"; additionally
- the NSW Government is quite happy to utilise our heavily populated urban community like guinea-pigs in a laboratory experiment to develop the necessary evidence.

Campbelltown Council, Camden Council, NSW Government, NSW Premier and the Planning Assessment Commission have key responsibilities with respect to providing consent to the AGL-CSG proposal, therefore each of the above stakeholders have a duty of care to the residents in the Campbelltown/Camden region; as such, if the above bodies allow the progress of the AGL-CSG proposal, they are likely to face a class action from residents in response to environmental damage which could have been prevented except for mal-administration.

We oppose in entirety the AGL-CSG Camden expansion proposal and have an expectation that the authorities charged with the responsibility of providing consent will also oppose the proposal.

I object to AGL's project application 09_0048 to mine for coal seam gas (CSG) in Campbelltown and Camden. The key reasons for my objection are stated below.

I am concerned that CSG mining is a technologically-evolving industry whose impacts have not been independently and scientifically fully researched and remain largely unknown. This view is supported by professional organisations and academics in evidence to the NSW Upper House and Senate Inquiries into Coal Seam Gas Mining in 2011 and by subsequent research here and overseas. We have had to rely on the industry for much of our information when the industry has a vested interest in the outcome. AGL is no different. It claims that the Camden Gas Project has been safely operating for 10 years. Yet we understand that impacts on groundwater and air quality have not been adequately monitored, and while AGL has been operating under an Environmental Protection Licence (EPL No. 12003), it has been allowed to self-monitor its compliance, self-investigate incidents and self-report such that we do not know what true impacts it may have had. Third party consultants and external laboratories that are engaged and paid for by the industry are not independent. Nor is any funded or cofunded research by the CSG mining industry. These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply concerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the future,

having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not been adequately assessed. While AGL claims that the *geology of the Sydney Basin is well known*, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that it does not know where the aquifers here run to but *probably Sydney Harbour*. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

My family has lived in and around the MacArthur region for the past 13 years. During this time, I have also been an assistant editor at the local Fairfax newspaper and have developed deep roots and connections with this community.

I have grave concerns around the expansion of coal seam gas wells into and close by what are and what will be dense residential areas. Those tens of thousands of people moving into proposed new developments will never have the opportunity to speak up about this even thought the extraction process will continue right under their properties.

I am particularly concerned that this expansion has been allowed through what appears to be the use of a loophole in the legislation that classifies this development as a utility installation rather than what it is - an extractive industry. While this may be within the letter of the law I suspect it was not the intent of the law to allow CSG extraction by describing it as a utility installation.

Should this expansion be allowed to go ahead under the classification of a utility installation, it will set a precedent that could potentially allow similar extractive developments to occur in already heavily built-up areas. It should not be forgotten that this coal and shale seam runs all the way to the Sydney CBD.

One of the outstanding features of the location of the wells has been their proximity to watercourses. Should there be any chemical leakage from some of these wells or a dramatic increase in salinity - which has been noted as a distinct possibility within AGL's own report - this would affect a watercourse that runs right through the heart of Harrington Park, within metres of a public school, and into local lakes where many residents congregate for recreation.

It should be noted the watercourses around Smeaton Grange and Gregory Hills all eventually run into the Nepean/Hawkesbury catchment.

It also concerns me that major gas lines follow exactly the path of a canal that feeds Sydney's drinking water.

AGL has not clearly explained how they will dispose of wastewater from this extraction process. What is the method of water and chemical disposal proposed and how can they ensure the community none of the waste will be dumped on their doorstep?

Recently, AGL admitted in a newspaper article that the horizontal drilling they intended to use between some of these wells was no longer possible and that hydraulic fracturing would be used instead. Hydraulic fracturing, also known as fracking, has a very poor history. Despite geologic surveys suggesting it will have very little effect on the water table and subsidence in some areas there have been numerous incidences where the results have not matched these forecasts.

It has been acknowledged by numerous researchers of fracking and gas extraction, that assessments produced by the experts often assess just one well. What they do not take into account is that each site can take up six wells and will be fracked on average 16 times. The close proximity of these wells to each other and the number of extraction attempts means that any assessment should model an exact pattern of sites and the total number of wells in close proximity. This does not appear to have been done.

Recent legislation has banned certain chemicals from being used in

fracking. However, none of these banned chemicals include heavy metals, which are known to be in the fracking mixture as can be clearly seen in the AGL report. Contamination of waterways and soil by heavy metals can have severe effects on both the health of the environment and residents.

In addition, if there are indeed problems as a result of this development, past experience has shown that it will be extraordinarily difficult for those affected to prove the source of the problem is related to gas extraction. In the great majority of cases it requires a civil action has to be brought before the courts, which can be very expensive, and the resulting determination by the court often results in a solution that falls short of what is required.

Finally, the maps of this project in the AGL submission document are muddled and very unclear, making it inordinately difficult to construct a submission opposing this development. Some of the maps include wells that are not included in other maps and many of the figures have very poor legends. One map online shows a planned well-head between the areas of Narellan, Harrington Park and Smeaton Grange. This does not appear anywhere else and there is no indication of an existing construction on this site.

Should AGL decide to go through this process again in the future, as today they have postponed the public process, it would be pleasing if further time could be given to put in additional submissions. My family and I will certainly be reviewing all the AGL documents, so that when this comes around again – as inevitably it will – we will have a more complete and thorough understanding of the proposal and its potential consequences.

Please accept this as a submission on the Camden Gas Project Stage 3 Northern Expansion which is currently on public exhibition. I object to AGL's project application 09_0048 to drill for coal seam gas in Western Sydney.

Please put the health and wellbeing of the people of Greater Western Sydney above the profits of AGL who plan to expand their gas field around and under people's homes and businesses.

I urge you to reject the proposal by AGL to drill 66 new coal seam gas production wells on the grounds that:

- Reports from Queensland and overseas show that there are serious risks to air quality and human health from unconventional gas drilling. However there have been no detailed studies done to quantify those risks especially in urban areas. The people of Camden and Campbelltown should not be treated like guinea pigs in a coal seam gas experiment.

- People's homes should not be undermined by coal seam gas drilling without their knowledge or permission.

- Homeowners face declining property values within and adjoining coal seam gas fields with some estimating house values may fall up to 30%.

- The integrity of gas wells can't be guaranteed and research from gas fields in Queensland and the US has shown many fail in their first few year. This will leave the community to deal with the impact of leaking wells on air quality and local water supplies.

- New research from Southern Cross University on methane gas leaks from coal seam gas fields has not been considered in the proposal. AGL has not conducted these studies to account for methane leakage on their existing coal seam gas wells.

- Despite research from the Queensland and the US suggesting ground water contamination and gas leaks from fracking, the proposal by AGL will allow fracking.

- The impacts of horizontal drilling have not been adequately considered in the Environmental Assessment.

- There are alternatives to coal seam gas, including renewable energy which can offer energy security without the unacceptable environmental and health risks posed by coal seam gas extraction.

My family moved to Camden South (SUBURB NAME) in 2005 for the great location, employment opportunities and a great lifestyle for our 3 children. With a selection of new and established schools, Campbelltown TAFE, the University of Western Sydney, Industrial Estates, Employment Zones, Town Centres and Sporting Facilities close by it seemed a perfect place to settle down for the long-term and raise a family.

Unfortunately, my youngest son has developed asthma since we moved here. We did not realise that the air quality is deceptively poor – in fact, the worst polluted atmospheric **Airshed** in Greater Sydney. If we can't breathe here, we can't live here. **Air Quality** is the critical health issue for all of us out here.

Please accept this as a submission on the Camden Gas Project Stage 3 Northern Expansion which is currently on public exhibition. I object to AGL's project application 09_0048 to drill for coal seam gas in Western Sydney.

Please put the health and wellbeing of the people of Greater Western Sydney above the profits of AGL who plan to expand their gas field around and under people's homes and businesses.

I urge you to reject the proposal by AGL to drill 66 new coal seam gas production wells on the grounds that:

- Reports from Queensland and overseas show that there are serious risks to air quality and human health from unconventional gas drilling. However there have been no detailed studies done to quantify those risks especially in urban areas. The people of Camden and Campbelltown should not be treated like guinea pigs in a coal seam gas experiment.

- People's homes should not be undermined by coal seam gas drilling without their knowledge or permission.

- Homeowners face declining property values within and adjoining coal seam gas fields with some estimating house values may fall up to 30%.

- The integrity of gas wells can't be guaranteed and research from gas fields in Queensland and the US has shown many fail in their first few year. This will leave the community to deal with the impact of leaking wells on air quality and local water supplies.

- New research from Southern Cross University on methane gas leaks from coal seam gas fields has not been considered in the proposal. AGL has not conducted these studies to account for methane leakage on their existing coal seam gas wells.

- Despite research from the Queensland and the US suggesting ground water contamination and gas leaks from fracking, the proposal by AGL will allow fracking.

- The impacts of horizontal drilling have not been adequately considered in the Environmental Assessment.

- There are alternatives to coal seam gas, including renewable energy which can offer energy security without the unacceptable environmental and health risks posed by coal seam gas extraction.

Content: State Significant Development - Stage 3 Northern Expansion of the Camden Gas Project

I have many reasons for my objection to this project. These objections are outlined below.

1 - IMPACTS ON AIR QUALITY & THE NEED FOR FUGITIVE EMISSIONS MONITORING

The Camden Local Government Area (LGA) is well known to accumulate much of Sydney's air pollution. Afternoon winds blow much of Sydney's pollution from traffic, the airport, shipping terminal and oil refineries into the south west Sydney basin. The Sydney South West area already has the highest rate of asthma and respiratory illnesses in NSW.

There have been no studies in our area to show what the current levels of methane and carbon dioxide are. In order to assess if there has been any leakage, a baseline study on existing gas levels needs to have been undertaken in order to serve as a comparison to future gas levels. There have been no studies to show the likely level of fugitive emissions associated with CSG operations. If leakage does occur, this would have a negative impact on our health, as well as our environment as carbon dioxide is 25 times more greenhouse intense than methane.

2- IMPACTS ON WATER QUALITY

I do not believe AGL have taken into account the historic coal mining activities that have already taken place in the Camden LGA. I am very concerned about the cumulative impacts on water quality at a regional level. There has been no regional scale water assessment study on the impacts of CSG operations.

A significant portion of land will be affected by de-watering, given water must be removed from the coal seam in order for the gas to be extracted. AGL has stated that each gas well will have horizontal drilling up to a 2.5km radius. When groundwater is removed, there is a "zone of influence" of approximately 2-3km that is also de-watered. Given the Nepean River is within this "zone of influence" of de-watering, I am very concerned about the long-term impacts of CSG operations on groundwater and the river. There are some people in my LGA whose livelihood relies on water extraction licences from the Nepean River for livestock and agriculture.

For the Camden Gas Project, one horizontal well will produce approximately 750,000L during its first 12 months. If a gas well operates for approximately 15-20 years, each well could be removing 15 million litres of groundwater. It is estimated that is could take decades to centuries before

groundwater levels return to normal.

In the absence of a regional assessment on water quality, that properly takes into consideration previous coal mining activities and effects on groundwater and aquifers, I do not want CSG to be further expanded in the Camden LGA.

3- LAND USE CONFLICTS

The proposed Northern Expansion of CSG wells is in the heart of the Sydney South West Growth Centre. The wells are located near existing houses, as well as in areas undergoing subdivision and/or re-zoning. AGL states that their normal practice is to locate wells at least 200-300 metres from the nearest residential dwelling. The CU02 well in Gregory Hills will be just 30 metres away from the nearest future residential dwelling. This is completely unacceptable.

AGL have tried to depict Camden LGA as entirely rural. Out-dated maps and photos of the Camden LGA have been used and there are now houses in areas that are depicted as rural paddocks in AGL's material. Development has occurred and will continue at lightning speed. The proposed project area is in the dead centre of one of the fastest growing residential areas in the state, so it defies logic to be approving gas wells where an extra 250,000 people will be living.

If approved, which I hope it will not be, I would request that appropriate and visible signage is compulsory for land around the CSG well site.

If approved, which I hope it will not be, I would also request that the State Government updates its Section 149(2) certificates so that there is a section for Council to advise new purchasers that they will be purchasing a site within a CSG area. Currently, it is illegal for Council to put this information on a Section 149(2) certificate, which is the certificate all new home owners purchase. If someone is buying land within a CSG area, they should be told about it upfront and it should not be hidden.

4 - NOISE IMPACTS

There will be huge acoustic impacts especially during the construction of each well. The Camden Northern Expansion is proposing 6 new locations with up to 6 well heads at each location. It takes approximately 28 days to construct one well head. If there are going to be 6 well heads at each location, it means there will be approximately 6 months of construction. This construction will take place 24 hours a day 7 days per week, as drilling cannot stop during the process. To have this type of constant noise near residential areas is completely unacceptable.

After construction, there is also the ongoing operational drilling noise. Ongoing operational noise can be up to 90dB for one well. If you were 80 metres away, this would be 5db louder than a conversation. As the drilling noise is a low frequency rumble/hum, noise attenuation would be very difficult. Almost all houses surrounding the wells will be built on concrete slabs and this low rumble/hum may be felt or heard in their house/backyard through vibrations.

Residents deserve a peaceful amenity in and around their own homes, and long-term noise pollution from the proposed wells would be extremely stressful to residents.

5 - NO FRACCING

I am completely against any type of fraccing. There are 23 possible chemicals used in fraccing. AGL have only assessed two of these chemicals, independently of each other. No testing of different combinations of chemicals has been completed. AGL state that if fraccing were to be used, then they would use things that were commonly found in a household pantry. Just because some chemicals are found in a house, does not make them safe, many are poisonous and when mixed together in a CSG environment, who knows what the chemical reaction will be and how this will affect groundwater and aquifers? Some of the chemicals that could be used in fraccing are benzene and paint thinner, not just sand and water, as stated by AGL. In the absence of an independent study on these chemicals, in combination with each other, in a CSG environment, I do not want fraccing to take place in Camden.

CONCLUSION

I would like to unequivocally state my objection to this project. The Camden LGA is situated in the South West Growth Centre and will see 100,000 new homes built very closely to many of the proposed well sites. Many existing residents within my LGA will face the prospect of horizontal drilling underneath their homes. There are huge concerns over reduced property values for homes located within the 2.5km radius of each well site. It is unknown if homes will suffer from long-term structural damage and if there will be any leakage, like what has been seen in Queensland.

I am very concerned there have been no long-term studies of CSG on human health or the environment. It would take many decades to see the long-term impacts. Just because AGL state there have been no detrimental examples in the last 5, 10, 15 years, does not make it safe. For example, it took many decades to see the devastating health impacts of being exposed to asbestos.

Independent, long-term, expert studies are required before any CSG operations are allowed to take place in the middle of a huge residential area. Until this time, I am completely opposed to this project.
