I urge you to reject the proposal by AGL to drill 66 new coal seam gas production wells on the grounds that:

- Reports from Queensland and overseas show that there are serious risks to air quality and human health from unconventional gas drilling. However there have been no detailed studies done to quantify those risks especially in urban areas. The people of Camden and Campbelltown should not be treated like guinea pigs in a coal seam gas experiment.
- People's homes should not be undermined by coal seam gas drilling without their knowledge or permission.
- Homeowners face declining property values within and adjoining coal seam gas fields with some estimating house values may fall up to 30%.
- The integrity of gas wells can't be guaranteed and research from gas fields in Queensland and the US has shown many fail in their first few year. This will leave the community to deal with the impact of leaking wells on air quality and local water supplies.
- New research from Southern Cross University on methane gas leaks from coal seam gas fields has not been considered in the proposal. AGL has not conducted these studies to account for methane leakage on their existing coal seam gas wells.
- Despite research from the Queensland and the US suggesting ground water contamination and gas leaks from fracking, the proposal by AGL will allow fracking.
- The impacts of horizontal drilling have not been adequately considered in the Environmental Assessment.

My family moved to. KERA O.S......(SUBURB NAME) in 2005 for the great location, employment opportunities and a great lifestyle for our 3 children. With a selection of new and established schools, Campbelltown TAFE, the University of Western Sydney, Industrial Estates, Employment Zones, Town Centres and Sporting Facilities close by it seemed a perfect place to settle down for the long-term and raise a family.

Unfortunately, my youngest son has developed asthma since we moved here. We did not realise that the air quality is deceptively poor – in fact, the worst polluted atmospheric Airshed in Greater Sydney. If we can't breathe here, we can't live here. My family and I have been living in Gregory Hills for the past year. I have kept this submission rather late in order to gather as much information on this issue which will affect my family and I directly as we are residents of Gregory Hills and will be in view of well head CU02. The well head itself may nor be in our suburb but the horizontal aspect of the drilling will be under our home.

After listening, watching and reading many media stories on this issue, it has become apparent that the only party interested in going forward with this project is AGL with considerable backing from the Planning Minister and consequently the Premier.

Local MP's all of whom are in the current government have come out in opposition to the project. Other state authorities, NSW Health, have also questioned the validity and safety of the current practice and called for a further delay of the project until further assessments can be made. Community groups with information from reliable scientific studies both here and overseas have been vocal in their opposition. Ordinary people who are just worried need to have a voice that is listened to not a token acknowledgement and then ignored.

Experiences of this process in Queensland and overseas has shown that both the human and environmental consequences are too great for it to continue where it now takes place let alone expand to create more wells.

The process of hydraulic fracturing is flawed in it's action and it's consequences. Surely disturbing the underlying rock layers causes problems to those layers above. Residue from the 'fracking' fluids will remain in the ecosystems for many years to come. Ground water flows into aquifers and eventually find it's way onto the surface albeit many years later.

Will the State Government and AGL take responsibility for those people and properties affected now and in the future? A short term gain for a major long term loss is not a smart move. The alleged huge amount of revenue for the State coffers and the myriad of jobs are nothing more than propaganda that AGL can afford repeat to listeners and viewers on radio and TV advertisements. The information leaflet that was delivered to our letterbox was nothing more than a glossy flyer with a poor excuse for a map with no reference points such as major roads and our

suburb of Gregory Hills was not even on the map. There were just a few coloured dots to indicate that CSG well were planned. This was laughable!

I often here the line from AGL that CSG mining is a "clean" form of energy. This makes no sense. As a high school chemistry teacher I know that if a hydrocarbon such as methane is burnt it produce carbon dioxide. This will contribute to global warming.

The self regulation of this industry is a complete joke. How can this be happening? Of course they are going to say that everything is fine. I noted with interest a recent press release from AGL in regards to bubbles of gas coming from underneath flood waters in the Menangle area. There are intelligent people in this community who are familiar with scientific data and the techniques used to measure such examples. I object to AGL's project application 09_0048 to mine for coal seam gas (CSG) in Campbelltown and Camden. The key reasons for my objection are stated below.

I am concerned that CSG mining is a technologically-evolving industry whose impacts have not been independently and scientifically fully researched and remain largely unknown. This view is supported by professional organisations and academics in evidence to the NSW Upper House and Senate Inquiries into Coal Seam Gas Mining in 2011 and by subsequent research here and overseas. We have had to rely on the industry for much of our information when the industry has a vested interest in the outcome. AGL is no different. It claims that the Camden Gas Project has been safely operating for 10 years. Yet we understand that impacts on groundwater and air quality have not been adequately monitored, and while AGL has been operating under an Environmental Protection Licence (EPL No. 12003), it has been allowed to self-monitor its compliance, self-investigate incidents and self-report such that we do not know what true impacts it may have had. Third party consultants and external laboratories that are engaged and paid for by the industry are not independent. Nor is any funded or cofunded research by the CSG mining industry. These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply concerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the future,

having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not been adequately assessed. While AGL claims that the *geology of the Sydney Basin is well known*, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that it does not know where the aquifers here run to but *probably Sydney Harbour*. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

Yet we understand that impacts on groundwater and air quality have not been adequately monitored, and while AGL has been operating under an Environmental Protection Licence (EPL No. 12003), it has been allowed to self-monitor its compliance, self-investigate incidents and self-report such that we do not know what true impacts it may have had. Third party consultants and external laboratories that are engaged and paid for by the industry are not independent. Nor is any funded or cofunded research by the CSG mining industry. These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in Its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply concerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the future,

having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not been adequately assessed. While AGL claims that the *geology of the Sydney Bosin is well known*, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that It does not know where the aquifers here run to but *probably Sydney Harbour*. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering plpeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

I am writing to you as a concerned resident of Varroville and as an adjoining land owner to the Carmelite nuns and the Serbian School in regards to the AGL Northern Expansion of the Camden Gas Project to which I must stress my strong OBJECTION!

In the beginning we had issues as adjoining land owners - Lot 2DP 845124 Glensaugh Pty Ltd - to the proposed WELL 07 and had not previously been contacted in regards to this proposal during the consultative process. We had only learned of this proposal at the time of lodging our last submission through other adjoining property owners the Carmelite nuns.

There are a number of issues we are concerned with that bring us to our total objection of this project within the Scenic Hills and surrounding areas.

We are concerned about the nature of what the impact of this is going to have on our land given it is so close. The concerns about the long-term sterilisation of this land and the impact that implies - decreased land value!

My daughter, Karen, has requested formally to yourself and also the minister for planning to be informed where the new locations of these wells are to be, especially the well heads. She has NOT to this date been informed even though she has requested more than once. In fact I believe she has not even received an acknowledgement of receipt of the requests. I have grave concerns if the original proposal of WELL 11 is still in place. The maps provided on your website are very vague.

If WELL 11 is still in place I hold grave concerns about contamination due to off-runs into the creeks, streams and land. The people around this area rely on the dam's water supply which is where WELL 11 is to be built. So our concerns are doubled in this respect. The impact of possible interrupted supplies, the possibility of contamination and also the long-term impact on the soil. There is also the concern to do with our livestock that rely on the pastures to graze and also which drink from the creeks, streams, dams and the like which may well become contaminated if AGL's proposal is to go ahead. What impact does or would this have on the cattle: deaths, lower birth rates. What about the meat of these cattle, as these cattle go off to

There are already many health concerns which have been raised by residents in Tara QLD. These concerns have been ongoing and the Queensland government and AGL have turned a blind eye to it all. These health concerns are from people living within a 6 kilometre radium in a rural setting. Now AGL want to mine through areas where people will be exposed at even closer proximity.

AGL needs to place this expansion project on hold until such a time that the general public can be 100% assured that a) our health is not going to be compromised; b) our land values are not going to be affected; c) our lives are not going to be disrupted by noise pollution; d) our wildlife, flora and fauna are not under threat; e) we are not going to have issues with air pollution; and e) our aesthetics of our surroundings is not ruined. Firstly it was as adjoining land owner - Lot 2DP 845124 Glensaugh Pty Ltd to the proposed WELL 07 - that we had not previously been contacted in regards to this proposal during the consultative process. We had only learned of this proposal at the time of lodging our last submission through other adjoining property owners the Carmelite nuns.

There are a number of issues we are concerned with that bring us to our total objection of this project within the Scenic Hills and surrounding areas. I live In Eschol Park and have done for 27 years. Prior to that I lived in Varroville since 1972, so I am a long-term resident of the Campbelltown district. In my previous submission (Glensaugh P/L) I outlined a great many number of concerns. My concerns for the area of Varroville are outlined in that submission.

Moreover I am concerned with this new amendment that AGL are now proposing which entails many gas wells in Eschol Park and Kearns. These suburbs are small suburbs, which are residential and house many young families, who are fortunate enough to have a rural outlook onto the beautiful Scenic Hills. It's not often people can say they live in a suburb yet hear the bellowing of a cow or cows at night. We are truly blessed to be surrounded by the aesthetics of the Scenic Hills and I would like to see it remain that way.

I am very much concerned about the issue of air pollution, run-off, heavy traffic such as semi-trailers and prime movers coming through my small suburb. These maps were a long time coming, especially given my first request was on 12th December 2012. Now they finally arrive one day off submissions closing. These could have been emailed to me back in December, so I have to ask myself why the delay...

The location of proposed wells, especially in Eschol Park, Kearns, Eaglevale and Claymore are extremely troublesome and I totally object to them. Proposed wells CU22 and CU 31 are in very close proximity to the existing water supply and canal known as the 'water race'. This is concerning due to that local residents and other areas rely on this water supply for drinking water. Varroville is supplied by water in a small dam at the water race. I am troubled that there will be issues of seepage and run-off and this could end up in our water supply. There is real concern of contamination. I also note that proposed wells CU6, CU10 and CU 14 are also in close proximity to this existing water canal, along with being close to natural dams which supply water to animals. This is totally unacceptable.

I also note that well CU02 is close to the existing water canal and in fact is planned to have the gathering line through part of a very large dam. Once again I must note the dangers of contamination into our dams which animals drink from and also the seepage of chemicals into the ground.

I also notice that VV03 in Varroville is still in close proximity to the Carmelite Nuns and the other monastery in Varroville. It also appears it will be located at the back of Mt Carmel High School, once again putting children, and teaching staff under potential health risks. Moreover, there are also the residents who are at higher risk as they stand to lose value on their properties and well as contamination in one form or another.

I must raise again the alarm I feel about having so many wells in the Eschol Park, Kearns, Eaglevale and Claymore areas. No-one to date can tell us whether this CSG mining/fracking is safe in an urban environment. I once again must stress the importance of duty of care that the NSW state government has to its people and that they cannot not allow AGL to go ahead and continue this expansion with a 'wait and see' approach. It is totally irresponsible. Full independent long-term investigations into Tara Qld health and environment concerns must take precedence.

Investigate these over a period of years before making any commitment to mining in our community here. If this mining is safe, why are they having the same health issues as what has been documented in the United States? Also is the issue of devalued land. Residents in Tara Qld are stuck on their properties as noone wants to buy into that area. I have grave concerns it will become the same here in our area.

The government and AGL both need to consider that asbestos poisoning took a long time, and in fact many deaths, before it became apparent what was the direct cause. James Hardy knew full well there were problems and turned a blind eye. Consequently as this was ignored and allowed to continue on. According to the Mesothelioma Center, approximately 10,000 deaths have already occurred in Australia with an additional 25,000 more estimated over the next four decades.

CSG mining/fracking and health concerns have already been raised by residents in Tara Qld and also in the United States of America where CSG fracking is done. All suggest there are serious health implications associated with this. So how can the NSW government, especially knowing what happened with Asbestos, even consider or allow AGL to continue with this project already knowing there are many health issues. In 2010 Bill Shorten stated in interview with the Sydney Morning Herald that 642 people had died that year from lung cancer associated with asbestos.

So how can the NSW government and AGL turn a blind eye given the residents of Tara Qld have already raised health concerns. It just does not make sense that both the state government and AGL are ignoring what top health professionals are stating. Where is our proof, as residents, this is not going to be harmful? We already know our land values will plummet because of this CSG mining/fracking as we have seen this in Tara Qld because no-one wants to willingly buy into an area that is contaminated and many residents are forced to stay because of this very reason as they cannot afford to leave with nothing.

We have already seen recently an issue with bubbling in flood waters around producing gas wells in the Menangle Park area adjoining the Nepean River near Campbelltown (Camden Gas Project Stage 2) to which AGL are self-investigating. This is not sufficient and no self-reporting in these types of matters should occur. There was an issue with Rosalind Park gas processing plant, near Camden, where AGL breached its protocol for checking air quality. This was apparently for a considerable amount of time. AGL do not have a good track record of staying within protocol and were apparently supposed to be 'self-reporting' this air quality checking. How can we have any faith in AGL...

I iterate there needs to be full independent investigations of current issues with CSG in regards to Tara QId and also issues on current protocols that AGL have breached to date. It is the NSW state government's responsibility – duty of care – to ensure these investigation are performed over a period of years into the true impact of what this mining/fracking will have in residential areas. It needs to be performed by independent environmental scientists and experts, health professional experts and scientists, along with land and agricultural scientists and experts.

AGL are prepared to risk the lives of potentially hundreds of thousands of residents, could possibly be more if it ends up in our water supply, all for 5% of gas supply in NSW. This just does not make sense. They are ignoring the outcry from residents, the media, scientists and the like. The best they can do is make statements that it is safe but they have no real proof! Once again it makes me question what does the government stand to gain by supporting AGL's expansion plans? There has to be something in order for them to even remotely consider allowing this project to continue!

Make AGL prove there is no risk, as they seem to be bold enough to make this statement, but on the other hand make statements to the effect of let us 'wait and see' what happens.

So which is it. Is it safe AGL to be fracking in residential areas or is it the big unknown and you are playing Russian Roulette with potentially hundreds of thousands of residents? How can we even be sure that we would even be told if there were any negative impacts as to date they have not stuck to protocol. For AGL to make any claim there is no risk, they need to be able to back that up with hard core independent evidence to prove their case. They need to be able to give us 100% guarantee that we, as residents, will not be affected health wise, monetary wise and that our environment – flora/fauna, livestock, domestic animals etc., will not be negatively affected by this CSG mining/fracking before this expansion project can even be remotely considered.

I am calling on the government of NSW to put its people first as you owe us a duty of care! Listen to resident concerns and also the medical specialists and environmental scientists who have gone public about the real concerns of CSG fracking and mining. I urge the NSW government to place AGL on notice and investigate their current operations and breaches of protocol. To put this project on hold until we can be assured 100% that our health and lives are not at risk. That CSG fracking is not going to damage and/or contaminate the environment that we call home. That our house and land values will not be devalued. That CSG fracking/mining is not going to impact negatively on our livelihood in any shape or form.

The biggest question I have though is why is the NSW government even consider taking such a huge risk for 5% of gas supply. Personally I would like to see the NSW government suspend this Camden/Campbelltown expansion project indefinitely. We export the majority of the gas Australia already produces. Why are we not looking at using 5% of what we currently export to supply for NSW?!

I am writing to you about our concerns in regards to the AGL Northern Expansion of the Camden Gas Project to which I must stress my strong OBJECTION! This is the second time I have had to object to this!

Firstly it was as adjoining land owner – Lot 2DP 845124 Glensaugh Pty Ltd to the proposed WELL 07 - that we had not previously been contacted in regards to this proposal during the consultative process. We had only learned of this proposal at the time of lodging our last submission through other adjoining property owners the Carmelite nuns.

There are a number of issues we are concerned with that bring us to our total objection of this project within the Scenic Hills and surrounding areas. I live In Eschol Park and have done for 27 years. Prior to that I lived in Varroville since 1972, so I am a long-term resident of the Campbelltown district. In my previous submission (Glensaugh P/L) I outlined a great many number of concerns. My concerns for the area of Varroville are outlined in that submission.

Moreover I am concerned with this new amendment that AGL are now proposing which entails many gas wells in Eschol Park and Kearns. These suburbs are small suburbs, which are residential and house many young families, who are fortunate enough to have a rural outlook onto the beautiful Scenic Hills. It's not often people can say they live in a suburb yet hear the bellowing of a cow or cows at night. We are truly

blessed to be surrounded by the aesthetics of the Scenic Hills and I would like to see it remain that way.

I am very much concerned about the issue of air pollution, run-off, heavy traffic such as semi-trailers and prime movers coming through my small suburb. It will cause Eschol Park to become polluted and our land values will decrease. Who would want to buy into an area where they is constant disruption, air pollution and potential health risks...

We have a number of schools in close proximity to the proposed wells and this is alarming. We also have an abundance of wonderful recreational parks which are frequented by sporting clubs and also by children and families for leisurely activities such as walking, riding bikes etc. All this is under great threat because AGL want to, I believe, put 6 wells into Eschol Park.

I am concerned about the nature of what the impact of this is going to have on my land given the numerous wells will be in close proximity. I am also concerned about the compounding effect of having so many wells close together in such a small area. I have concerns about the long-term sterilisation of this land and the impact that implies – decreased land value! But more importantly our health!!!

There is also the impact of emission from these wells to be considered. I chose to live in Eschol Park because it is small and still has a rural aspect about it when you look upon the Scenic Hills as its backdrop, along with the many parks it offers. We could end up with a human and/or natural disaster on our hands that is irreversible! I personally do not want to be part of an experiment of 'wait and see'!

I have requested formally to yourself and also the minister for planning to be informed of the exact locations of these wells, especially the well heads. I have NOT to this date been informed even though I have requested more than once. In fact I have not even received a reply.

The Scenic Hills is a protected area, and is so for a reason. It is basically the last truly beautiful natural part of the Campbelltown district. Lush rolling hills which are home to a few lucky people and much flora and fauna – some of which I believe are endangered. Given I grew up in this area I recall when the whole of St Andrews, Raby etc., were all farms. I watched the changes occur with growth but one of the most appealing things that kept me in this area was the Scenic Hills. Now AGL is proposing to put an eyesore smack bang in the middle of it which is potentially dangerous to flora, fauna and human life itself. Chemicals being leeched into the groundwater some of which are highly toxic! Further erosion of the land. Noise pollution. Emissions. The total opposite of what this stretch of land is all about... This area is about preservation not destruction, and AGL want to do this for a lousy 5% of gas supply...

There are already many health concerns which have been raised by residents in Tara QLD and I am personally concerned about this issue as well. Equally concerned that the Qld government and AGL have not investigated this fully! These concerns have been ongoing and the Queensland government and AGL have turned a blind eye to it all. These health concerns are from people living within a 6 kilometre radius in a rural setting. Now AGL want to mine through areas where people will be exposed at an even closer proximity.

AGL needs to be forced to place this expansion project on hold until such a time that the general public can be 100% assured that a) our health is not going to be compromised; b) our land values are not going to be affected; c) our lives are not going to be disrupted by noise pollution; d) our wildlife, flora and fauna are not under threat; e) we are not going to have issues with air pollution; and e) our aesthetics of our surroundings is not ruined. They are just a few that come to mind.

It is abhorrent that the NSW government and AGL consider that it 'necessary' to carry out this mining and fracking in order to determine evidence. Evidence should be taken from Tara Qld. A full review and independent investigations into the health and safety of both human life and our environment should be performed in regards to this mining and fracking in Tara before any further work is undertaken. Also reports should come from the United States where CSG has occurred and similar health complaints have

been reported as in Tara Qld. Even top health professionals here in Australia have been stating about these high risks and yet it all seems to fall on deaf ears!!

Until full independent investigative reports are performed, disclosed, and can be provided to the public on this issue in Tara Qld, no further CSG mining should take place. It is totally irresponsible of both the NSW government and AGL to take a 'wait and see approach!!' This experimental mining, which is exactly what it is when it comes to urban mining, has the potential to be worse than the asbestos disaster.

We still have no idea what will happen if aquifers become affected. Once something like this affects our water works there is no turning back and all living things on earth require water to live! How is a 'wait and see' approach going to counteract that?!

We have already seen a number of breaches of protocol when it comes to maintaining current wells at Menangle NSW. In fact recently there were reports of bubbling around the wells after the deluge of rain we received. AGL wanted to carry out their own investigations into this. This is not acceptable, and should not be allowed. It should be independent bodies with no financial or personal interest or gain to AGL or NSW state government that perform these investigations. They should be made up of professional scientific bodies.

In regards to Eschol Park, during heavy rain periods we always experiences areas of flooding in our parks and run off from the Scenic Hills. So what effects will that have in this area if gas wells are not managed properly.

How can we feel confident about anything to do with this project when AGL have failed to manage what wells they currently have in place, and fail to investigate what is happening in Tara Qld.

The Campbelltown/Camden district is home to approximately 150,000 people with expansion currently underway estimated at 500,000, and the NSW government and AGL are prepared to risk all our lives for the sake of 5% of gas for NSW. It seem to be a very high risk to take for such a small percentage of gas. I have asked this question before and I am asking it again, Why is the NSW government and AGL prepared to take such a huge risk with human life and our environment for 5% of gas?

I also hold grave concern that having AGL come in and set up shop will set the precedence for the Scenic Hills area to be become 'unprotected', therefore destroyed. Having just the proposal in place has already devalued our block of land in Varroville and also now in Eschol Park.

I would urge that the NSW state government looks into this very carefully and knocks this project on the head ASAP! Do not use the residents of Camden/Campbelltown as your guinea pigs, as that is basically what both the NSW government and AGL are proposing to do. Investigate Tara Qld thoroughly. Gain you so-called evidence and PROVE to the residents of this area that we have nothing to worry about, instead of adopting a 'wait and see' mentality! It is the NSW state government who owe a duty of care to the residents of Camden/Campbelltown to ensure 100% that our health and environment is not going to be compromised. A 'wait and see' approach is not the solution. The solution is investigating what is happening at Tara. Investigate the breaches of AGL with current wells.

As a long term resident of Campbelltown I absolutely totally object to this expansion project! I would also like to know why this project is so important when it is only for 5% of NSW gas supply. I would like to know what the government gaining from allowing this project to go through? As it seems ludicrous to think that a state government would put its people, land and water supply under such high risk of contamination in one form or another for such a small percentage of gas supply! The figures do not add up...

I object to AGL's project application 09_0048 to mine for coal seam gas (CSG) in Campbelltown and Camden. The key reasons for my objection are stated below.

I am concerned that CSG mining is a technologically-evolving industry whose impacts have not been independently and scientifically fully researched and remain largely unknown. This view is supported by professional organisations and academics in evidence to the NSW Upper House and Senate Inquiries into Coal Seam Gas Mining in 2011 and by subsequent research here and overseas. We have had to rely on the industry for much of our information when the industry has a vested interest in the outcome. AGL is no different. It claims that the Camden Gas Project has been safely operating for 10 years. Yet we understand that impacts on groundwater and air quality have not been adequately monitored, and while AGL has been operating under an Environmental Protection Licence (EPL No. 12003), it has been allowed to self-monitor its compliance, self-investigate incidents and self-report such that we do not know what true impacts it may have had. Third party consultants and external laboratories that are engaged and paid for by the industry are not independent. Nor is any funded or cofunded research by the CSG mining industry. These lessons should have been learnt with asbestos in Australia and with 'Big Tobacco' in the USA. The National Water Commission in its Position Statement (3rd December 2010) said that impacts may emerge over a long time period. I am deeply concerned that the costs of unforeseen problems will be borne by the community and taxpayers after AGL is long gone from the area. This is grossly irresponsible.

Doctors for the Environment Australia claims that health impacts from CSG mining have not been assessed. Preliminary research from Queensland (e.g. by Southern Cross University in Tara) and overseas is deeply concerning, especially where fracking has been used. As at December 2011, 85% of the production wells in the Camden Gas Project had been fracked (evidence from the NSW Upper House Inquiry) with inadequate monitoring of its impacts on water in particular. AGL claims that the use of horizontal wells in the proposed Stage 3 will reduce the need for fracking, but it seems that this is not entirely true since it has reserved the right to frack these wells in the future if/when the technology becomes available. The size of the proposed well clusters and any fracking of horizontal wells are both new and untested here. It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has not already contributed to this or that it can be managed in the future,

having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. I object to AGL's project application 09-0048 to mine for coal seam gas in Campbelltown and Camden. I am writing because myself and my family and neighbours are concerned for our health and safety and the safety of our drinking water from the threat of fracking by AGL. AGL has reversed its pledge not to use the controversial drilling technique of fracking in the Western suburbs. AGL has lied to the Government and it has lied to, and misled residents in the Western suburbs.

AGL told Fairfax Media unconditionally on December 27 that it would not use fracking, a drilling method linked to water and soil pollution, in its planned 66-well drilling program between Liverpool and Campbelltown. AGL's assurances prompted the Premier, Barry O'Farrell, to defend AGL's promise not to frack and to downplay any impacts of the project on the thousands of residents who live near drilling sites.

However, after internal discussions revealed the company would have to change the drilling plans it has already submitted to the state Government, AGL has now backtracked on its pledge. It now says it would prefer to use a "horizontal drilling" technique to extract gas, but reserves the right to revert to "vertical drilling" which would lead to "well stimulation", or fracking. A spokeswoman for AGL has said "AGL's position remains consistent that drilling vertical wells ... remains unlikely, however if any vertical well is drilled in the future, such a well will likely require fracture well stimulation to promote the flow of natural gas.'

Fracking in urban areas is a very risky proposition that could pollute the air and water with methane, other gases and fracking chemicals, posing a risk to the health of residents in the area and a risk to the air we breathe and the environment generally. The people of western Sydney should not be used as guinea pigs in AGL's fracking experiments.

AGL have admitted that 75 per cent of their existing wells outside urban Sydney have required fracking and the permeability of the coal seams means that they always needed to use fracking to extract the gas.

Fracking, or hydraulic fracturing, involves pumping a mix of water, sand and chemicals underground at high pressure, to force more gas to the surface. Fracking can cause gas leaks, damage aquifers and pollute water with its mix of toxic chemicals. However, it is favoured by drilling companies at some sites because it usually extracts more gas, and makes more money, than conventional drilling. This is a money-grabbing exercise by AGL who are only concerned with their profits and have absolutely no scruples about destroying the health and wellbeing of those of us who live in western Sydney.

AGL has said that the decision on whether to frack wells in western Sydney will now be made on a case-by-case basis, depending on geological and environmental conditions. It claims that it has reversed its stance on fracking in the interests of transparency. "The CSG industry has some of the country's most stringent environmental and safety regulations that AGL must adhere to and we are committed to meeting all of these," a spokeswoman said. The hypocrisy inherent in these statements is glaring and very frightening to those of us who live in western Sydney.

About 10,000 homes in the proposed drilling area have been notified of the company's plans by newsletters. AGL has promised there will be no effects at the surface from its underground drilling. It is quite clear that AGL cannot possibly and does not have any intention of keeping this promise.

All of us who live in the area are extremely frightened and concerned about the potential effects on human health, on the soil and the environment. We are also worried about the effect this will have on our property values, many of our homes already being worth less than we paid for them since the Global Financial Crisis.

Residents now face the prospect of coal seam gas trucks and industrial rigs regularly using our streets, months of noisy drilling and the very real possibility that our water supply will be polluted. We do not want to turn on our taps and find that our drinking water is so polluted with gas that the water coming from the tap can be set alight with a match. This can cause explosions and the prospect is very upsetting and disturbing to myself and my family and neighbours.

It is very disappointing that the O'Farrell government has not done anything to protect residents. Something must be done to stop AGL. Coal seam gas drilling in or near residential areas is simply unacceptable and we urge you not to stand by and let this happen.

It will therefore be entirely experimental with unknown outcomes on health and property including the possibility of subsidence under so many urban properties.

I am also concerned about evidence from Queensland and overseas on air quality and the cumulative impact of AGL's expansion into an area that already experiences incidents of unacceptable levels of air pollution (ozone and fine particles) associated with respiratory problems (NSW Environmental Protection Authority). AGL's past performance gives no confidence that it has <u>not</u> already contributed to this or that it can be managed in the

future, having admitted in August this year that it had not conducted continuous air monitoring at its Rosalind Park Gas Treatment Plant for three years in breach of its EPL No.12003.

Allowing CSG mining in areas that are not zoned for heavy industry undermines zoning controls and confidence in the planning process, and creates severe land use conflicts, economic instability and inequity. It will disrupt religious communities whose vocations have so far been protected by the Scenic Hills zoning; it will place undue burden on small rural allotments whose capacity to cope is severely reduced by size (thereby threatening the survival of the entire historic Scenic Hills), and it is unsightly and unsafe in urban areas with a potential escalation in CSG mining incidents and accidents associated with the more intense urban activity (traffic, people etc.), the presence of children, and potential for vandalism. The consequent impact on land and house values for existing land and home owners may be devastating. For many people the home is their largest asset and is often leveraged to support small business. Any devaluation by bank assessors may destroy livelihoods and life savings.

I do not believe that the NSW Government's new regulations for CSG mining will ensure its safe operation here. As the only commercially producing CSG field in NSW, the Camden Gas Project has already been operating under consent conditions. Yet the NSW Government has not been able to ensure compliance, as evidenced by on-going breaches by AGL of its licence conditions, and the discovery of incidents that might not have been reported were it not for community vigilance, such as the Sugarloaf well incident in May 2011 in Menangle that allowed well contents to drift over Sydney's water channel and to nearby Glen Alpine houses.

The proposal poses risks to Sydney's water in general and to the South West in particular that have not been adequately assessed. While AGL claims that the geology of the Sydney Basin is well known, AGL's rationale for the constant modification of prior stages of the Camden Gas Project seems to contradict this, as does its admission to the Scenic Hills Association that it does not know where the aquifers here run to but probably Sydney Harbour. Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

Potential impacts on Sydney Harbour, on the nearby Sydney Water Catchment, and AGL's proposal to run its gas gathering pipeline along Sydney's Upper Canal on public land are unacceptable risks to Sydney's water, and are an abuse of public property for the benefit of private investors.

AGL will only ever produce about 5% of NSW's gas from the Camden Gas Project according to evidence it gave under oath at the NSW Upper House Inquiry. This does not justify the risks and potential costs to the community, particularly since 150,000+ people already live and work in the immediate affected area, and this is in Sydney's south west growth corridor. It is socially, environmentally and economically unjustified, and has no social licence to operate here.

Please accept this as a submission on the Camden Gas Project Stage 3 Northern Expansion which is currently on public exhibition. I object to AGL's project application 09_0048 to drill for coal seam gas in Western Sydney.

Please put the health and wellbeing of the people of Greater Western Sydney above the profits of AGL who plan to expand their gas field around and under people's homes and businesses.

I urge you to reject the proposal by AGL to drill 66 new coal seam gas production wells on the grounds that:

- Reports from Queensland and overseas show that there are serious risks to air quality and human health from unconventional gas drilling. However there have been no detailed studies done to quantify those risks especially in urban areas. The people of Camden and Campbelltown should not be treated like guinea pigs in a coal seam gas experiment.
- People's homes should not be undermined by coal seam gas drilling without their knowledge or permission.
- Homeowners face declining property values within and adjoining coal seam gas fields with some estimating house values may fall up to 30%.
- The integrity of gas wells can't be guaranteed and research from gas fields in Queensland and the US has shown many fail in their first few year. This will leave the community to deal with the impact of leaking wells on air quality and local water supplies.
- New research from Southern Cross University on methane gas leaks from coal seam gas fields has not been considered in the proposal. AGL has not conducted these studies to account for methane leakage on their existing coal seam gas wells.
- Despite research from the Queensland and the US suggesting ground water contamination and gas leaks from fracking, the proposal by AGL will allow fracking.
- The impacts of horizontal drilling have not been adequately considered in the Environmental Assessment.
- There are alternatives to coal seam gas, including renewable energy which can offer energy security without the unacceptable environmental and health risks posed by coal seam gas extraction.

I am writing to submit my opposition to the AGL Coal Seam Gas Expansion on a number of grounds. The long term consequence of mining in urban areas has not been adequately researched over a long enough period of time for me to feel that this is without risk of adverse consequence to the community. The "fracing" technology which will possibly be used in the future does have some evidence of poor outcome when not properly managed. I feel that allowing any sort of expansion of CSG mining in this area is putting my family, my community, and our environment at unacceptable

Recently the Nepean River flooded the gas well at Menangle. Surely the burden of evidence should rest with the companies to prove that this has had no impact on the waterway and the local environment? We do not want to wait for irreparable damage to the Nepean waterway to decide that this has been a bad idea.

This area does have some experience with mining under our houses and businesses. This has resulted in a problem with subsistence - houses shifting and dropping causing huge amounts of damage. The Mining Subsistence Board then attempts afterwards to fix the house at huge inconvenience and loss of value for the owners. How can it be guaranteed that this will not happen under our homes and businesses with this expansion of AGL CSG Mining?

We need long term research showing that this can be done safely under and around urban areas - we do not want or deserve to be the first guinea pigs. There is a documented 7% increase of methane gas when University of

QLD researchers tested air quality in the gas fields, which is assumed to be directly related to leakage from the well head. Industry "best practice" is 4%, which I believe to be still too high for a poisonous greenhouse gas in an area where we live, work and go to school.

I have a business in Camden that has approximately 150-200 residents through the doors each week. People are very concerned about the impact that this will have on our future, and the growing consensus is that we have been let down by the people in power who we have elected to represent our best interests.

The other impact on our quality of life is the industrialisation of our suburbs. In Camden we are proud "country town" outlook and history. With the proposed expansion, there will be noise pollution from the drilling and trucks, trucks will be driving through urban areas causing an increase in air pollution. There will have to be ponds for the water to stand in.

Again, may I reiterate my total opposition to the AGL CSG Camden Expansion Proposal, and I expect that all consenting authorities do likewise.

We did not realise that the air quality is deceptively poor - in fact, the worst polluted atmospheric Airshed in Greater Sydney. If we can't breathe here, we can't live here. Air Quality is the critical health issue for all of us out here.

Recently we became aware of the proposed expansion of AGL Coal Seam Gas drilling, mining and 'fracing' or 'fracturing' under our homes, schools, workplaces, football fields, cricket ovals, leisure centres, our community halls, our churches, our petrol stations, our overhead bridges, open spaces and catchment areas.

If we had known about the AGL-CSG expansion we would have avoided the area and a \$450,000 life-time

mortgage in a suburb destined for degrading and devaluing. It doesn't make any sense at all!

'Fracing' is actually "FRACTURING" - breaking and cracking the sub-surface under us. AGL falsely compares its 'fracing' chemistry is to 'harmless' products on a laundry shelf, when in fact the real chemicals in vast quantities are highly volatile producing toxic gaseous and particulate emissions to earth, water and air. AGL Con\$ultants have been grossly dishonest and deceitful in their minimal description of 'fracing' processes.

Despite misleading media reports AGL-CSG will definitely 'frac" under us. AGL's intentions are very clear in both their 2010 ENVIRONMENTAL ASSESMENT at Chapter 4.2 and in the 2012 MAIN REPORT at Chapter 3.4.

We are not against mining at all. However, introducing toxic and dangerous AGL Coal Seam Gas mining under our existing permissible land use zones of established and populated communities is totally inappropriate in every respect, and absolutely beyond our belief.

AGL conceals its toxic 'fracing' chemistry behind claims of 'commercial confidentiality'. We do know that AGL use concentrated acids and biocides among a huge list of chemical cocktails triggering volatile chemical reactions in coal and sandstone seams underneath our homes and schools. The fact that AGL will not disclose its 'fracing toxicology' is absolutely absurd - a nightmare with disastrous health and environmental consequences.

Mining is the most accident riddled industry in Australia. Mixing mining and untested chemistry under our homes as we sleep is a disastrous formula for major critical incidents. We don't need the threat of disaster, totally 'fracing' our dreams into nightmares, for over 20 years of sleeps, after busy days at school and work.

Do you and Minister Hazzard fully comprehend the potential implications of cumulative long-term toxic emissions to our earth, our water and breathing atmosphere? Have your planning experts fully analysed AGL's documents to find the serious omissions and false 'conceptual modelling' promoted as acceptable science?

We understand that AGL-CSG drilling, mining and 'fracing' under our populated and established communities is totally new to urban Australia, Is South Western Sydney AGL's and the O'Farrell Government's test case to expand toxic mining under metropolitan Sydney?

If you proceed with AGL's proposal you will be opening the pathway for a massive class action against all the decision makers, back door dealers and promoters of this toxic and hazardous industry.

We are not your "westie lab rats". We are not your experiment in 'social injustice' and socio-economic and environmental degradation? Don't do it in anyones' backyard. We know you'll never allow it in yours!

The major reasons why my family opposes the entire AGL Coal Seam Gas Expansion include — Threats to Air Quality and health

- Well documented historic poor air quality across the 'project area' and Greater South Western Sydney
- Serious health risks including dramatic increases in respiratory diseases and asthma
- South Western Sydney already has the highest incidence of hospital admissions for asthma
- Dangerously incomplete physical and chemical analysis of Coal Seam Gas 'fracing' processes Potential for long term undetected gaseous leaks forming toxic fugitive plumes in our breathing space
- Risks of uncontrollable toxic particulate emissions to earth, air and water threatening our communities
- Will the ICAC belatedly examine the post political mining careers of suspect politicians as we choke in AGL's neuro-toxins and overcrowd the very limited health resources in Sydney's South West?

Threats to Our Natural Environment - Geology and Hydrology

- Long term geological damage to drinking water, water aquifers, water tables, creek beds and rivers
- Contamination of South Creek and Narellan Creek feeding the Hawkesbury-Nepean Catchment
- Structural damage to the Sydney Water Supply Channel undermined by at least 6 parallel drilling locations in our area at CU02, CU06, CU10, CU14, CU20 and CU22 – each with 6 wells
- Structural damage to built environments and dangerous land slip in a predominantly clay sub soil
- Expansion and shrinkage of clay and shale sub-structures causing fracturing to gas pipes
- Irreversible damage to native flora and fauna, soil, and vegetation
- Risks in waste management of by-products including neuro-toxin particulates in earth, water and air Contradictory and Incompatible Land Use Layering
- Allowing legally established and developed residential, commercial, educational and recreational zonings - all funded by our rates and statutory government taxes - to be undermined, compromised and degraded by a toxic and dangerous mining industry

Unpredictable Noise Disturbance - AGL-CSG ConSultants noise studies are totally incompetent

- Inadequate credible studies into 24 hour drilling, mining and 'fracing' noise levels impacting on our health.
- Failure to acknowledge long term reflected and radiated sub-surface noise levels on sleeping disturbance patterns, neurological concerns given that the human perception of noise is six times greater at night time

Deeply Flawed Community Consultation - Lacking Honesty, Openness and Transparency

- AGL provided only 2 copies of the Environmental Assessment one at Camden Council foyer and one at Campbelltown – and withdrew the original Environmental Assessment October of 2010 so that the community could not compare the original proposal with the amended Main Report October of 2012
- Positioning the exhibition period leading into Christmas when families and work force are busy in preparation for the holiday season.
- Failure by AGL to accept that many people do not have access to the internet, and those who have Internet access would have great difficulty reading a 3000 page document on a computer screen
- Failure by AGL to provide complimentary CDs of their proposal to residents upon request a practice of previous proponents of major projects
- Poorly advertised, and consequently poorly attended, information sessions at which AGL specialist consultants could not answer questions - but would make notes
- A poorly designed AGL-CSG website a potluck table of contents, using out-of-date maps which do not clearly show the level of urban development, no index and illogical page numbering
- Using only small section and out of date maps so that it is impossible to view the enormity of the whole project when previous proponents have provided fold out A3 size maps
- Failure by AGL to show the 2,500 metre radiius of each drilling footprint under homes, schools and creeks
- Using an unidentifiable AGL-CSG public relations spokeswoman, unqualified in mine engineering, as the front person quoted in daily papers while keeping faceless "experts" in the next room
- The AGL-CSG COMMUNITY CONSULTATIVE COMMITTEE (CCC) does not adequately represent the broader community and that it does not keep accurate minutes and report back to the broader community

Political Posturing and Decision Making Processes

- Concerns that you, your government departments, including Environment and Health, have not carried out complete, professional, expert and independent analysis of the AGL-CSG proposal
- Concerns that the Premier in the media has already indicated his approval for the AGL-CSG proposal preempting the decision making process by the PLANNING ASSESSMENT COMMISSION (PAC) - a 'selected' panel of "experts" to undertake a "merit review" of the project
- It doesn't help when Premier O'Farrell insults us (SMH 7.7.13 page 7 Editorial) by trivialising drilling lines as being the size of a "teacup" when in fact AGL state in 2012 MAIN REPORT at Chapter 4.3 that drilling varies from 178mm to 2000mm in diameter in the 'fracing' reaming process and the lines are up to 2,500 metres long. There does not seem to be even a token separation between AGL and some politicians,
- It is not up to me, my family, or members of our community to prove that AGL's Coal Seam Gas mining is a serious risk to our local life, health and future. Camden Council, the State Government's statutory authorities, Ministers, Cabinet, Premier and PLANNING ASSESSMENT COMMISSION panel are the ultimate consenting authority, with a "duty of care" to all residents of South Western Sydney. It is your collective responsibility to protect our health, living, learning, working and recreational environments.
- Politicians, AGL and PAC Members do not have an anti-social licence to degrade our family lifestyle, our home, our backyard, our pools, our chook shed, our pigeon loft, our greyhound run, our veggie patch, our

soil, our water, our air and the vital future of our communities. We totally oppose the entire AGL-CSG Camden Expansion Proposal and expect that all consenting authorities do likewise.
