In response to General Requirements of DGR SSD 5967 2013, as requested by Lend Lease I have reviewed the capital investment value (as defined in clause 3 of the Environmental Planning and Assessment Regulation 2000) and report the following;

Batch Plant Set Up:

1. Capital Plant and Equipment Purchases	\$ 3,600,000.00
2. Civil Construction Works	\$ 175,000.00
3. Electrical and Hydraulic Services Plant and Equipment	\$ 403,000.00
3. Project Administration and Management	\$ 295,000.00
4. Technical and Quality Assurance Processes	\$ 15,000.00
5. Project Contingency	\$ 50,000.00
6. Decommissioning of plant	\$ 75,000.00
Total Batch Plant Setup Costs	\$ 4,613,000.00

Operational Costs:

1. Depreciation, Repairs and Maintenance	\$ 2,434,500.00
2. Operational manning during the project	\$ 1,769,736.00
Total Operational Costs	\$ 4,204,236.00

These calculations have been based upon the following assumptions;

1. Production volume of minimum 150,000m3 of concrete.
2. 27 month period of operation,
3. reflects the planned programme of activity as at the date of the commissioning of the plant,
4. excludes increased costs associated with delays and overtime,
5. excludes changes in costs arising from amended concrete production volumes to those originally planned as at the date of the commissioning of the plant.
