Hydraulic

- DGR 11. Infrastructure and Utilities:
 - 1. SPP have engaged Billbergia to liaise with Sydney water, a section 73 and NOR for Stage 2 are yet to be obtained;
 - 2. Sydney Water have confirmed once early works sewer main works are carried out that the authority main will be adequately sized to take all drainage discharges from Stage 2;
 - 3. Sydney Water have confirmed water main amplification will need to be undertaken along High St if Stage 2 building exceeds 25 metres in total height.
- DGR Consultation:
 - 1. Billbergia on behalf of SPP Group will continue to liaise with Sydney Water during the Stage 2 design and construction phase.
