


Modification of Development Consent

Development Approval: **SSD 6246** granted by the Planning Assessment Commission on 27 February 2014

For the following: Construction of multi-storey residential development comprising:

- two separate buildings ranging in height from four to eight storeys and eight to ten storeys containing 331 dwellings;
- a childcare centre for 90 children;
- basement and ground level parking;
- pedestrian and street network;
- associated landscaping; and
- subdivision.

Applicant: Karimbla Construction Services (NSW) Pty Ltd

Consent Authority: Minister for Planning

The Land: 100 Bennelong Parkway, Sydney Olympic Park

Modification: **SSD 6246 MOD 2:** the modification includes increasing the height of approved buildings to respond to amended road levels.
