We strongly object to the height of the proposed buildings along Wellington St Chippendale.

The area of land at the corner of Wellington and Balfour is narrow and the proposal is closer to existing buildings than any new structures in the Central Park Development

We are also extremely concerned that excavation could cause damage to the older buildings along Wellington St and remember the disasters with the Lane Cove Tunnel and the damage caused after heavy rain at the Collaroy excavation site.

There appears to be a significant increased height from the original concept plan to the proposal, considering the massing directly facing Wellington Street.

The concern is that this would have a negative impact on overshadowing for residents and businesses all the way along Wellington Street.

The recommendation from the 2007 Advisory Panel stated that 'building on the southern boundary should be a maximum of 15 metres to relate to the warehouses and related buildings in Chippendale'.

The original concept plan from Frasers (October 2008), hosted on their website, shows building heights of around 15m directly facing Wellington Street (28.8AHD - 32.00 AHD), with higher development set back towards the north.

The new proposal appears to show heights of approximately 15-20m higher (51AHD) directly facing the smaller scale buildings on Wellington Street. The amenity of all small scale buildings along Wellington Street would be affected - not only residential terrace houses but also existing businesses.
