## YASS VALLEY WIND FARM – INFRASTRUCTURE AMENDMENTS

Following ongoing discussions with your Department and the Office of Environment and Heritage we have made a small number of amendments to the project infrastructure layout including the following:

- 1. Removal of two wind turbines resulting in a final number of 132 wind turbines and associated infrastructure; and
- 2. Minor relocation of 4 wind turbines away from hollow bearing trees.

Enclosed with this letter is the A1 map of the final site layout incorporating the above amendments and presenting the final layout for assessment. Please note this map replaces the previous map and updates our September 2014 Preferred Project and Submissions Report. 
